- 2 relating to the boundaries of the Harris County Fresh Water Supply
- 3 District No. 58.

- 4 BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF TEXAS:
- 5 SECTION 1. DEFINITION. In this Act, "district" means the
- 6 Harris County Fresh Water Supply District No. 58.
- 7 SECTION 2. EXCLUSION OF TERRITORY. The boundaries of the
- 8 district are adjusted to exclude the following parcel of land:
- 9 BEING ALL THAT CERTAIN TRACT OR PARCEL OF LAND CONTAINING
- 10 138.03 ACRES OF LAND SITUATED IN THE WILLIAM WHITLOCK SURVEY,
- 11 ABSTRACT NO. 85, HARRIS COUNTY, TEXAS, AND BEING ALL OF A CALLED
- 12 60.288 ACRE TRACT BEING PLATTED AS INDIAN SHORES SECTIONS NINE (9)
- 13 AND TEN (10), UNRECORDED AND A CALLED 77.817 ACRE TRACT RECORDED IN
- 14 VOLUME 1250, PAGE 74 HARRIS COUNTY DEED RECORDS, SAID 138.03 ACRE
- 15 TRACT BEING THE SAME 138.0268 ACRE TRACT AS RECORDED IN H.C.C.F., NO
- 16 W777169 AND BEING MORE PARTICULARLY DESCRIBED BY METES AND BOUNDS,
- 17 AS FOLLOWS TO-WIT:
- Beginning at a 5/8 inch iron rod found in the north line of a
- 19 called 233.8 acre tract as recorded in H.C.C.F. No. Y604056 and
- 20 same being the Southeast corner of lot Four (4), Block Eighteen (18)
- 21 of Indian Shores Section 3, according to the map or plat recorded in
- 22 Volume 131, Page 32 Harris County Map Records (HCMR) and being the
- 23 Southeast corner of the called 60.288 acre tract and the Southeast
- 24 corner and PLACE OF BEGINNING of the tract herein described.

- 1 THENCE NORTH 87 DEGREES 42 MINUTES 19 SECONDS EAST, a
- 2 distance of 2299.67 feet with the north line of the Wheless tract to
- 3 a 1 inch iron pipe found for the Southwest corner Lot 1, Block 8 of
- 4 Rustic Acres Section 2, according to the map or plat recorded in
- 5 Volume 104, Page 809 Block Book for Harris County and being the
- 6 Southeast corner of the called 77.817 acre tract and the Southeast
- 7 corner of this tract herein described.
- 8 THENCE NORTH 17 DEGREES 11 MINUTES 18 SECONDS EAST, a
- 9 distance of 1499.32 feet, (called 1500.55 feet), with the west line
- 10 of said Rustic Acres Section 2 to a 5/8 inch iron rod found at the
- 11 intersection of the south right-of-way of Stoker Road, having a
- 12 right-of-way width of 100 feet, for the Northwest corner of Rustic
- 13 Acres Section 2 and same being the Southwest corner of Indian Shores
- 14 Section 6 according to the map of plat filed in Volume 165, Page 52
- 15 HCMR.
- 16 THENCE NORTH 17 DEGREES 05 MINUTES 22 SECONDS EAST, a
- 17 distance of 644.33 feet with the west line of said Indian Shores
- 18 Section 6 to a 5/8 inch iron rod found in the south line of Lot 2,
- 19 Block 6 of Indian Shores Section One according to the map or plat
- 20 recorded in Volume 119, Page 63 HCMR for the Northwest corner of
- 21 Indian Shores Section 6 and the Northeast corner of this tract
- 22 herein described.
- THENCE FOLLOWING THE SOUTH BOUNDARY OF INDIAN SHORES SECTION
- 24 ONE (1) IN A WESTERLY DIRECTION AS FOLLOWS
- THENCE SOUTH 87 DEGREES 51 MINUTES 26 SECONDS WEST, a
- 26 distance of 181.78 feet to a 5/8 inch iron rod found for an angle
- 27 point.

- 1 THENCE NORTH 84 DEGREES 11 MINUTES 58 SECONDS WEST, a
- 2 distance of 304.97 feet to a 1 inch iron pipe found for an angle
- 3 point,
- 4 THENCE NORTH 73 DEGREES 27 MINUTES 09 SECONDS WEST, a
- 5 distance of 274.25 feet to a 1/4 inch iron rod found for an angle
- 6 point,
- 7 THENCE NORTH 57 DEGREES 45 MINUTES 08 SECONDS WEST, a
- 8 distance of 954.57 feet to a 1 inch iron pipe found for the
- 9 Northeast corner of Lot One (1), Block Four (4) of Indian Shores
- 10 Section Two (2) according to the map or plat recorded in Volume 125,
- 11 Page 6 HCMR for the Northwest corner of this tract.
- 12 THENCE FOLLOWING THE EAST LINE OF SAID INDIAN SHORES SECTION
- 13 TWO (2) AS FOLLOWS:
- 14 THENCE SOUTH 40 DEGREES 25 MINUTES 36 SECONDS WEST, a
- 15 distance of 240.48 feet to a 1/2 inch iron rod found at the
- 16 Intersection with the south right-of-way of Running Bear Trail,
- 17 having a right-of-way width of sixty (60) feet.
- THENCE NORTH 45 DEGREES 58 MINUTES 51 SECONDS WEST, a
- 19 distance of 30.35 feet with the south right-of-way of Running Bear
- 20 Trail to a 3/8 inch iron rod found for the Northeast corner at Lot 1,
- 21 Block 10 of said Section 2,
- THENCE SOUTH 43 DEGREES 23 MINUTES 15 SECONDS WEST, a
- 23 distance of 223.16 feet to a 1/2 inch iron rod found for the
- 24 Southeast corner of said Lot 1, Block 10,
- THENCE NORTH 26 DEGREES 19 MINUTES 19 SECONDS WEST, a
- 26 distance of 28.88 feet to a 1/2 inch iron rod found for the
- 27 Northeast corner of Lot 2, Block 10,

- 1 THENCE SOUTH 71 DEGREES 13 MINUTES 06 SECONDS WEST, a
- 2 distance of 829.60 feet to a 5/8 inch iron rod found for the
- 3 Southwest corner of Lot 11, Block 13, Section 2,
- 4 THENCE SOUTH 18 DEGREES 44 MINUTES 18 SECONDS EAST, a
- 5 distance of 80.01 feet to a 5/8 inch iron rod found for an angle
- 6 point,
- 7 THENCE SOUTH 16 DEGREES 03 MINUTES 16 SECONDS WEST, a
- 8 distance of 523.67 feet to a 1 inch iron bolt found for an angle
- 9 point,
- 10 THENCE SOUTH 20 DEGREES 38 MINUTES 58 SECONDS WEST, a
- 11 distance of 1006.73 feet to a 1/2 inch iron rod found for an angle
- 12 point,
- 13 THENCE SOUTH 64 DEGREES 27 MINUTES 48 SECONDS EAST, a
- 14 distance of 214.94 feet to a 1/2 inch iron rod found for an angle
- 15 point and being the Northeast corner of White Dove Trail, having a
- 16 right-of-way width of sixty (60) feet,
- 17 THENCE SOUTH 22 DEGREES 15 MINUTES 37 SECONDS WEST, a
- 18 distance of 43.07 feet with the east right-of-way of said White Dove
- 19 Trail to a 3/4 inch iron rod found for the Northwest corner of Lot 1,
- 20 Block 17, Indian Shores Section 3,
- THENCE SOUTH 67 DEGREES 59 MINUTES 55 SECONDS EAST, a
- 22 distance of 170.27 feet to a 5/8 inch iron rod found for an angle
- 23 point,
- THENCE SOUTH 22 DEGREES 08 MINUTES 33 SECONDS WEST, a
- 25 distance of 125.02 feet to a 1/2 inch iron rod found for the
- 26 Northeast corner of Silver Moon Trail, having a right-of-way width
- 27 of 60 feet,

- 1 THENCE SOUTH 34 DEGREES 03 MINUTES 33 SECONDS WEST, a
- 2 distance of 293.77 feet to a 5/8 inch iron rod found for the most
- 3 south corner of Lot 5, Block 18, Section 3,
- 4 THENCE SOUTH 43 DEGREES 54 MINUTES 05 SECONDS EAST, a
- 5 distance of 151.12 feet to the PLACE OF BEGINNING and containing
- 6 138.03 acres more or less.
- 7 SECTION 3. RIGHTS OF BONDHOLDERS. The exclusion of
- 8 property under this Act does not diminish or impair the rights of
- 9 the holders of any outstanding and unpaid bonds, warrants, or other
- 10 certificates of indebtedness of the district.
- 11 SECTION 4. APPORTIONMENT OF DISTRICT INDEBTEDNESS.
- 12 (a) The excluded property is not released from the payment of its
- 13 pro rata share of the district's indebtedness.
- 14 (b) The district shall continue to levy taxes each year on
- 15 the property excluded from the district at the same rate levied on
- 16 other property of the district until the taxes collected from the
- 17 excluded property equal the property's pro rata share of the
- 18 indebtedness of the district on the effective date of this Act. The
- 19 taxes collected shall be applied exclusively to the payment of the
- 20 excluded property's pro rata share of the indebtedness.
- 21 (c) The owner of any part of the excluded property at any
- 22 time may pay in full the owner's share of the pro rata share of the
- 23 indebtedness of the district.
- 24 SECTION 5. (a) The legal notice of the intention to
- 25 introduce this Act, setting forth the general substance of this
- 26 Act, has been published as provided by law, and the notice and a
- 27 copy of this Act have been furnished to all persons, agencies,

- 1 officials, or entities to which they are required to be furnished
- 2 under Section 59, Article XVI, Texas Constitution, and Chapter 313,
- 3 Government Code.
- 4 (b) The governor, one of the required recipients, has
- 5 submitted the notice and Act to the Texas Commission on
- 6 Environmental Quality.
- 7 (c) The Texas Commission on Environmental Quality has filed
- 8 its recommendations relating to this Act with the governor, the
- 9 lieutenant governor, and the speaker of the house of
- 10 representatives within the required time.
- 11 (d) All requirements of the constitution and laws of this
- 12 state and the rules and procedures of the legislature with respect
- 13 to the notice, introduction, and passage of this Act are fulfilled
- 14 and accomplished.
- 15 SECTION 6. This Act takes effect immediately if it receives
- 16 a vote of two-thirds of all the members elected to each house, as
- 17 provided by Section 39, Article III, Texas Constitution. If this
- 18 Act does not receive the vote necessary for immediate effect, this
- 19 Act takes effect September 1, 2015.
