## A BILL TO BE ENTITLED

1	AN ACT
2	relating to the creation of the Rose City Municipal Utility
3	District; providing authority to issue bonds; providing authority
4	to impose assessments and fees.
5	BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF TEXAS:
6	SECTION 1. Subtitle F, Title 6, Special District Local Laws
7	Code, is amended by adding Chapter 7958 to read as follows:
8	CHAPTER 7958. ROSE CITY MUNICIPAL UTILITY DISTRICT
9	SUBCHAPTER A. GENERAL PROVISIONS
10	Sec. 7958.001. DEFINITIONS. In this chapter:
11	(1) "Board" means the district's board of directors.
12	(2) "City" means the City of Tyler.
13	(3) "Commission" means the Texas Commission on
14	Environmental Quality.
15	(4) "Director" means a board member.
16	(5) "District" means the Rose City Municipal Utility
17	District.
18	Sec. 7958.002. NATURE OF DISTRICT. The district is a
19	municipal utility district created under Section 59, Article XVI,
20	Texas Constitution.
21	Sec. 7958.003. CONFIRMATION AND DIRECTORS' ELECTION
22	REQUIRED. The temporary directors shall hold an election to
23	confirm the creation of the district and to elect five permanent
24	directors as provided by Section 49.102, Water Code.

- 1 Sec. 7958.004. CONSENT OF MUNICIPALITY REQUIRED. The
- 2 temporary directors may not hold an election under Section 7958.003
- 3 until each municipality in whose corporate limits or
- 4 extraterritorial jurisdiction the district is located has
- 5 consented by ordinance or resolution to the creation of the
- 6 district and to the inclusion of land in the district.
- 7 Sec. 7958.005. FINDINGS OF PUBLIC PURPOSE AND BENEFIT.
- 8 (a) The district is created to serve a public purpose and benefit.
- 9 (b) The district is created to accomplish the purposes of a
- 10 municipal utility district as provided by general law and Section
- 11 59, Article XVI, Texas Constitution.
- 12 Sec. 7958.006. INITIAL DISTRICT TERRITORY. (a) The
- 13 district is initially composed of the territory described by
- 14 Section 2 of the Act enacting this chapter.
- 15 (b) The boundaries and field notes contained in Section 2 of
- 16 the Act enacting this chapter form a closure. A mistake made in the
- 17 field notes or in copying the field notes in the legislative process
- 18 does not affect the district's:
- 19 (1) organization, existence, or validity;
- 20 (2) right to issue any type of bond for the purposes
- 21 for which the district is created or to pay the principal of and
- 22 <u>interest on a bond; or</u>
- 23 <u>(3) legality or operation.</u>
- SUBCHAPTER B. BOARD OF DIRECTORS
- Sec. 7958.051. GOVERNING BODY; TERMS. (a) The district is
- 26 governed by a board of five elected directors.
- 27 (b) Except as provided by Section 7958.052, directors serve

- 2 Sec. 7958.053. QUALIFICATIONS OF DIRECTORS.
- 3 (a) Notwithstanding any other law:
- 4 (1) an officer or employee of the city may serve as a
- 5 director of the district; and
- 6 (2) a member of the governing body of the city may
- 7 serve as a director of the district.
- 8 (b) A person who qualifies to serve as a director is
- 9 qualified to participate in all votes pertaining to the business of
- 10 the district, subject to Section 49.058, Water Code.
- (c) Section 49.052, Water Code, does not apply to the
- 12 district.
- Sec. 7958.054. COMPENSATION; REIMBURSEMENT. A director
- 14 serves without compensation but may receive reimbursement for
- 15 actual expenses reasonably and necessarily incurred while engaging
- 16 <u>in activities on behalf of the district.</u>
- SUBCHAPTER C. POWERS AND DUTIES
- 18 Sec. 7958.101. GENERAL POWERS AND DUTIES. The district has
- 19 the powers and duties necessary to accomplish the purposes for
- 20 which the district is created.
- Sec. 7958.102. MUNICIPAL UTILITY DISTRICT POWERS AND
- 22 DUTIES. The district has the powers and duties provided by the
- 23 general law of this state, including Chapters 49 and 54, Water Code,
- 24 applicable to municipal utility districts created under Section 59,
- 25 Article XVI, Texas Constitution.
- Sec. 7958.103. COMPLIANCE WITH MUNICIPAL CONSENT ORDINANCE
- 27 OR RESOLUTION. The district shall comply with all applicable

- 1 requirements of any ordinance or resolution that is adopted under
- 2 Section 54.016 or 54.0165, Water Code, and that consents to the
- 3 creation of the district or to the inclusion of land in the
- 4 district.
- 5 Sec. 7958.104. NO EMINENT DOMAIN POWER. The district may
- 6 not exercise the power of eminent domain.
- 7 SUBCHAPTER D. GENERAL FINANCIAL PROVISIONS
- 8 Sec. 7958.151. ELECTIONS REGARDING BONDS. The district may
- 9 issue, without an election, bonds and other obligations secured by
- 10 revenue other than ad valorem taxes.
- 11 Sec. 7958.152. PROHIBITION ON IMPOSITION OF TAXES.
- 12 (a) The district may not impose an ad valorem tax for any purpose.
- 13 (b) Section 49.107, Water Code, does not apply to the
- 14 district.
- 15 SUBCHAPTER E. BONDS AND OTHER OBLIGATIONS
- Sec. 7958.201. AUTHORITY TO ISSUE BONDS AND OTHER
- 17 OBLIGATIONS. The district may issue bonds or other obligations
- 18 payable wholly or partly from impact fees, revenue, contract
- 19 payments, grants, or other district money, or any combination of
- 20 those sources, to pay for any authorized district purpose.

- 4 SECTION 3. (a) The legal notice of the intention to
- 5 introduce this Act, setting forth the general substance of this
- 6 Act, has been published as provided by law, and the notice and a
- 7 copy of this Act have been furnished to all persons, agencies,
- 8 officials, or entities to which they are required to be furnished
- 9 under Section 59, Article XVI, Texas Constitution, and Chapter 313,
- 10 Government Code.
- 11 (b) The governor, one of the required recipients, has
- 12 submitted the notice and Act to the Texas Commission on
- 13 Environmental Quality.
- 14 (c) The Texas Commission on Environmental Quality has filed
- 15 its recommendations relating to this Act with the governor, the
- 16 lieutenant governor, and the speaker of the house of
- 17 representatives within the required time.
- 18 (d) All requirements of the constitution and laws of this
- 19 state and the rules and procedures of the legislature with respect
- 20 to the notice, introduction, and passage of this Act are fulfilled
- 21 and accomplished.
- 22 SECTION 4. This Act takes effect September 1, 2015.
