A BILL TO BE ENTITLED 1 AN ACT 2 relating to the creation of the Rose City Municipal Utility District; providing authority to issue bonds; providing authority 3 to impose assessments and fees. 4 BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF TEXAS: 5 SECTION 1. Subtitle F, Title 6, Special District Local Laws 6 7 Code, is amended by adding Chapter 7958 to read as follows: CHAPTER 7958. ROSE CITY MUNICIPAL UTILITY DISTRICT 8 9 SUBCHAPTER A. GENERAL PROVISIONS Sec. 7958.001. DEFINITIONS. In this chapter: 10 (1) "Board" means the district's board of directors. 11 12 (2) "City" means the City of Tyler. (3) "Commission" means the Texas Commission on 13 14 Environmental Quality. 15 "Director" means a board member. (4) 16 (5) "District" means the Rose City Municipal Utility 17 District. 18 Sec. 7958.002. NATURE OF DISTRICT. The district is a municipal utility district created under Section 59, Article XVI, 19 Texas Constitution. 20 21 Sec. 7958.003. CONFIRMATION AND DIRECTORS' ELECTION REQUIRED. The temporary directors shall hold an election to 22 23 confirm the creation of the district and to elect five permanent directors as provided by Section 49.102, Water Code. 24

Sec. 7958.004. CONSENT OF MUNICIPALITY REQUIRED. 1 The 2 temporary directors may not hold an election under Section 7958.003 until each municipality in whose corporate limits or 3 extraterritorial jurisdiction the district is located 4 has consented by ordinance or resolution to the creation of 5 the district and to the inclusion of land in the district. 6 7 Sec. 7958.005. FINDINGS OF PUBLIC PURPOSE AND BENEFIT. (a) 8 The district is created to serve a public purpose and benefit. 9 (b) The district is created to accomplish the purposes of a 10 municipal utility district as provided by general law and Section 59, Article XVI, Texas Constitution. 11 12 Sec. 7958.006. INITIAL DISTRICT TERRITORY. (a) The district is initially composed of the territory described by 13 14 Section 2 of the Act enacting this chapter. 15 (b) The boundaries and field notes contained in Section 2 of

16 <u>the Act enacting this chapter form a closure. A mistake made in the</u> 17 <u>field notes or in copying the field notes in the legislative process</u> 18 <u>does not affect the district's:</u>

19 organization, existence, or validity; (2) right to issue any type of bond for the purposes 20 for which the district is created or to pay the principal of and 21 interest on a bond; or 22 23 (3) legality or operation. 24 SUBCHAPTER B. BOARD OF DIRECTORS Sec. 7958.051. GOVERNING BODY; TERMS. (a) The district is 25 26 governed by a board of five elected directors. 27 (b) Except as provided by Section 7958.052, directors serve

S.B. No. 2066 1 staggered four-year terms. Sec. 7958.052. TEMPORARY DIRECTORS. (a) The temporary 2 3 board consists of: 4 (1) Martin Heines; (2) John Nix; 5 (3) Sam Mezayek; 6 7 (4) Darryl Bowdre; and 8 (5) Edward Broussard. (b) Temporary directors serve until the earlier of: 9 (1) the date permanent directors are elected under 10 Section 7958.003; or 11 12 (2) September 1, 2019. (c) If permanent directors have not been elected under 13 14 Section 7958.003 and the terms of the temporary directors have 15 expired, successor temporary directors shall be appointed or reappointed as provided by Subsection (d) to serve terms that 16 17 expire on the earlier of: (1) the date permanent directors are elected under 18 19 Section 7958.003; or 20 (2) the fourth anniversary of the date of the 21 appointment or reappointment. 22 (d) If Subsection (c) applies, the owner or owners of a majority of the assessed value of the real property in the district 23 24 may submit a petition to the commission requesting that the commission appoint as successor temporary directors the five 25 persons named in the petition. The commission shall appoint as 26 successor temporary directors the five persons named in the 27

1 petition. 2 Sec. 7958.053. QUALIFICATIONS OF DIRECTORS. (a) 3 Notwithstanding any other law: 4 (1) an officer or employee of the city may serve as a 5 director of the district; and 6 (2) a member of the governing body of the city may 7 serve as a director of the district. 8 (b) A person who qualifies to serve as a director is qualified to participate in all votes pertaining to the business of 9 10 the district, subject to Section 49.058, Water Code. 11 (c) Section 49.052, Water Code, does not apply to the 12 district. Sec. 7958.054. COMPENSATION; REIMBURSEMENT. A director 13 serves without compensation but may receive reimbursement for 14 15 actual expenses reasonably and necessarily incurred while engaging in activities on behalf of the district. 16 17 SUBCHAPTER C. POWERS AND DUTIES Sec. 7958.101. GENERAL POWERS AND DUTIES. The district has 18 19 the powers and duties necessary to accomplish the purposes for which the district is created. 20 21 Sec. 7958.102. MUNICIPAL UTILITY DISTRICT POWERS AND DUTIES. The district has the powers and duties provided by the 22 general law of this state, including Chapters 49 and 54, Water Code, 23 24 applicable to municipal utility districts created under Section 59, 25 Article XVI, Texas Constitution. 26 Sec. 7958.103. COMPLIANCE WITH MUNICIPAL CONSENT ORDINANCE OR RESOLUTION. The district shall comply with all applicable 27

2	Section 54.016 or 54.0165, Water Code, and that consents to the
3	creation of the district or to the inclusion of land in the
4	<u>district.</u>
5	Sec. 7958.104. NO EMINENT DOMAIN POWER. The district may
6	not exercise the power of eminent domain.
7	SUBCHAPTER D. GENERAL FINANCIAL PROVISIONS
8	Sec. 7958.151. ELECTIONS REGARDING BONDS. The district may
9	issue, without an election, bonds and other obligations secured by
10	revenue other than ad valorem taxes.
11	Sec. 7958.152. PROHIBITION ON IMPOSITION OF TAXES. (a) The
12	district may not impose an ad valorem tax for any purpose.
13	(b) Section 49.107, Water Code, does not apply to the
14	<u>district.</u>
15	SUBCHAPTER E. BONDS AND OTHER OBLIGATIONS
16	Sec. 7958.201. AUTHORITY TO ISSUE BONDS AND OTHER
17	OBLIGATIONS. The district may issue bonds or other obligations
18	payable wholly or partly from impact fees, revenue, contract
19	payments, grants, or other district money, or any combination of
20	those sources, to pay for any authorized district purpose.

21 SECTION 3. (a) The legal notice of the intention to 22 introduce this Act, setting forth the general substance of this 23 Act, has been published as provided by law, and the notice and a 24 copy of this Act have been furnished to all persons, agencies, 25 officials, or entities to which they are required to be furnished 26 under Section 59, Article XVI, Texas Constitution, and Chapter 313, 27 Government Code.

1 (b) The governor, one of the required recipients, has 2 submitted the notice and Act to the Texas Commission on 3 Environmental Quality.

4 (c) The Texas Commission on Environmental Quality has filed 5 its recommendations relating to this Act with the governor, the 6 lieutenant governor, and the speaker of the house of 7 representatives within the required time.

8 (d) All requirements of the constitution and laws of this 9 state and the rules and procedures of the legislature with respect 10 to the notice, introduction, and passage of this Act are fulfilled 11 and accomplished.

SECTION 4. This Act takes effect September 1, 2015.
