1 A JOINT RESOLUTION

- 2 proposing a constitutional amendment to provide for the governor's
- 3 and lieutenant governor's terms of office to begin at 10 a.m. on the
- 4 day preceding the day the regular legislative session convenes.
- 5 BE IT RESOLVED BY THE LEGISLATURE OF THE STATE OF TEXAS:
- 6 SECTION 1. Section 4, Article IV, Texas Constitution, is
- 7 amended to read as follows:
- 8 Sec. 4. The Governor elected at the general election in 2018
- 9 [1974], and thereafter, shall be installed at 10 a.m. on the day
- 10 preceding the day set by law for the convening of the regular
- 11 session of the legislature [first Tuesday after the organization of
- 12 the Legislature, or as soon thereafter as practicable, and shall
- 13 hold [his] office for the term of four years, or until \underline{a} [his]
- 14 successor shall be duly installed. The Governor [He] shall be at
- 15 least thirty years of age, a citizen of the United States, and shall
- 16 have resided in this State at least five years immediately
- 17 preceding the [his] election.
- SECTION 2. Section 16(a), Article IV, Texas Constitution,
- 19 is amended to read as follows:
- 20 (a) There shall also be a Lieutenant Governor, who shall be
- 21 chosen at every election for Governor by the same voters, in the
- 22 same manner, [continue in office for the same time,] and possess the
- 23 same qualifications. The voters shall distinguish for whom they
- 24 vote as Governor and for whom as Lieutenant Governor. The

- 1 Lieutenant Governor shall hold office for a term of four years. The
- 2 Lieutenant Governor shall take office following the election, at 10
- 3 a.m. on the day preceding the day set by law for the convening of the
- 4 regular session of the legislature, and shall serve thereafter for
- 5 the full term of years to which elected.
- 6 SECTION 3. The following temporary provision is added to
- 7 the Texas Constitution:
- 8 <u>TEMPORARY PROVISION.</u> (a) This temporary provision applies
- 9 to the constitutional amendment proposed by the 84th Legislature,
- 10 Regular Session, 2015, providing for the governor's and lieutenant
- 11 governor's terms of office to begin the day preceding the day the
- 12 regular legislative session convenes.
- 13 (b) The amendments to Sections 4 and 16(a), Article IV, of
- 14 this constitution apply to a person elected to the office of
- 15 governor or lieutenant governor for a term beginning on or after
- 16 <u>January 1, 2019.</u>
- 17 <u>(c) This temporary provision expires January 1, 2020.</u>
- 18 SECTION 4. (a) This proposed constitutional amendment
- 19 shall be submitted to the voters at an election to be held November
- 20 3, 2015, only if the secretary of state certifies that an enactment
- 21 of the 84th Legislature, Regular Session:
- 22 (1) provides for the canvass of election returns for
- 23 the offices of governor and lieutenant governor by the attorney
- 24 general; and
- 25 (2) was not vetoed by the governor and becomes law
- 26 contingent on adoption of this constitutional amendment by the
- 27 voters.

- 1 (b) If the secretary of state does not make a certification 2 under Subsection (a), this resolution has no effect.
- 3 (c) If the election on this amendment is held, the ballot
- 4 shall be printed to permit voting for or against the proposition:
- 5 "The constitutional amendment to provide for the governor's and
- 6 lieutenant governor's terms of office to begin at 10 a.m. on the day
- 7 preceding the day the regular legislative session convenes."
