







Notice is hereby given of the intention to introduce a bill in the Regular Session of the 84th Session of the Legislature of the State of Texas to create the Grand Lake Estates Management District. The district will be created as a special district under and pursuant to the provisions of Section 59, Article XVI, Texas Constitution, and pursuant to the power of the Legislature to create special government agencies and districts for the purposes of constructing, financing and operating public infrastructure and improvements within and outside the district and promoting the economic development of the State of Texas, Montgomery County, and neighboring communities.

GENERAL BOUNDARY DESCRIPTION

A 47,200.35 acre tract located west of Grand Lake Estates Subdivision Section 11 and south of Grand Lake Estates Section 6 and 8, in southwest Montgomery County.
