**NOTICE OF INTENT TO  
INTRODUCE A BILL**

Pursuant to the Constitution and laws of the State of Texas, notice is hereby given of the intention to apply to the 84th Legislature of the State of Texas at its regular session in Austin, Texas for the introduction of a bill, the substance of the contemplated law being as follows:

An act relating to the powers, duties, and requirements of certain conservation and reclamation districts and special purpose districts.

The Act applies to the following districts: CNP Utility District; East Montgomery County Municipal Utility District No. 3; East Montgomery County Municipal Utility District No. 4; Encanto Real Utility District; Harris County Municipal Utility District No. 5, of Harris County, Texas; Harris County Utility District No. 16; Harris County Municipal Utility District No. 61; Harris County Water Control and Improvement District No. 119; Harris County Municipal Utility District No. 150; Harris County Municipal Utility District No. 211, of Harris County, Texas; Harris County Municipal Utility District No. 233, of Harris County, Texas; Post Wood Municipal Utility District; West Park Municipal Utility District; East Montgomery County Municipal Utility District No. 8; East Montgomery County Municipal Utility District No. 9; East Montgomery County Municipal Utility District No. 10; East Montgomery County Municipal Utility District No. 11; East Montgomery County Municipal Utility District No. 12; East Montgomery County Municipal Utility District No. 13; East Montgomery County Municipal Utility District No. 14; Harris County Municipal Utility District No. 483; Harris County Municipal Utility District No. 484; Harris County Municipal Utility District No. 485; Liberty County Municipal Utility District No. 2; Liberty County Municipal Utility District No. 3; Liberty County Municipal Utility District No. 5; Montgomery County Municipal Utility District No. 100; and Montgomery County Municipal Utility District No. 101. The Act proposes to extend the deadline for each of the above Districts to submit information regarding eminent domain authority to the Texas Comptroller and to restore eminent domain authority if the new deadline of December 31, 2015 is met.

All interested persons will, therefore, take notice of the matters and facts set out in the foregoing statement of the substance of the contemplated laws as required by the Constitution and laws of the State of Texas.
