### NOTICE OF INTENT TO INTRODUCE A BILL

Pursuant to the Constitution and laws of the State of Texas, notice is hereby given of the intention to apply to the 84th Legislature of the State of Texas at its regular session in Austin, Texas for the introduction of a bill, the substance of the contemplated law being as follows:

An act relating to the jurisdiction of the Constitutional County Court of Jefferson County, Texas and amending Section 26.223 Texas Government Code, as follows:

Sec. 26.223. JEFFERSON COUNTY. (a.) If the county judge is licensed to practice law in this state, the County Court of Jefferson County has jurisdiction concurrent with the County Court at Law of Jefferson County over all causes and proceedings, civil and criminal, juvenile and probate, original and appellate, over which by the constitution and general laws of this state county courts have jurisdiction.

(b.) If the county judge is not licensed to practice law in this state, the County Court of Jefferson County has concurrent jurisdiction with the county court at law only in probate proceedings, administration of estates, guardianship proceedings, mental illness proceedings, and juvenile jurisdiction as provided by Section 26.042(b).

All interested persons will therefore take notice of the matters and facts set out in the foregoing statement of the substance of the contemplated law as required by the Constitution and laws of the State of Texas.
