Relating to the state's burden of proof in certain criminal asset forfeiture proceedings.

Relating to the expunction of arrest records and files relating to certain nonviolent offenses.

HB 1064 Sheffield
Relating to prohibiting certain sex offenders from working or residing within or otherwise going in, on, or within a certain distance of premises where children commonly gather; providing a penalty.

Relating to the preservation of toxicological evidence collected in connection with certain intoxication offenses.

Relating to search warrants issued to obtain a DNA specimen through a buccal swab or another method.

Relating to the expunction of certain files and records arising from a criminal investigation; creating a criminal offense.

Relating to the admissibility of certain evidence in the prosecution of offenses involving family violence and other similar offenses committed against a member of the defendant's family or household.

HB 2970 Herrero
Relating to the use of money paid as restitution to or on behalf of certain individuals depicted in child pornography.

HB 3046 Herrero
Relating to the prosecution of the offense of failure to identify; creating a criminal offense.

HB 3276 Dutton
Relating to automatic expunction of arrest records and files for certain persons who are tried for an offense and subsequently acquitted.

HB 3338 Alonzo
Relating to the appointment of counsel for indigent defendants arrested for, charged with, or taking appeal from a conviction of an assault punishable by fine only.

HB 3388 Faircloth
Relating to increasing the fee on conviction paid by a defendant for a peace officer committing or releasing the defendant.

HB 3415 Canales
Relating to the award of court costs, storage fees, and attorney's fees in a criminal asset forfeiture proceeding.

HB 3553 Keffer
Relating to the definition of peace officer for purposes of intercepting or collecting information in relation to certain communications in an investigation of criminal conduct.

HB 3578 Alonzo
Relating to the date on which certain criminal defendants are eligible to file a petition for an order of nondisclosure.

HB 3579 Alonzo
Relating to the expunction of records and files relating to an offense for which a person is arrested.

HB 3580 Alonzo
Relating to the procedure for an application for a writ of habeas corpus after a plea of guilty or nolo contendere.

HB 3893 Canales
Relating to the recording and disclosure of certain grand jury proceedings that involve a governmental employee.

HB 3936 Herrero | et al.
Relating to an order of nondisclosure of certain criminal history record information.
