HB 108 Guillen  
Relating to certain lottery prize winners' choice to remain anonymous.

HB 1504 Canales  
Relating to a lottery prize winner's choice to remain anonymous on authorization to withhold five percent of winnings.

HB 1385 Raymond  
Relating to local option elections to legalize or prohibit the operation of eight-liners; providing penalties; imposing fees.

HB 1830 Kuempel | et al.  
Relating to the regulation and permitting of amusement redemption game rooms; authorizing fees; creating a civil penalty and criminal offense.

HB 2745 Capriglione  
Relating to the frequency restrictions on charitable raffles.

HB 3093 Guillen  
Relating to the permissible value of a residential dwelling offered or awarded as a prize at a charitable raffle.

HB 3255 Goldman  
Relating to the interests of certain holding companies in other holding companies that own a repair facility.

HB 3839 Deshotel  
Relating to the operation of casino gaming in this state by licensed persons in certain areas of this state to provide additional money for residual windstorm insurance coverage in the coastal areas; requiring occupational licenses or certifications; creating criminal offenses and providing other penalties; authorizing fees; imposing a tax.

HJR 22 Nevárez  
Proposing a constitutional amendment to authorize the Kickapoo Traditional Tribe of Texas to conduct gaming by executing a gaming agreement with this state; providing for licensing of persons under the agreement; limiting certain taxes and fees.

HJR 92 Raymond  
Proposing a constitutional amendment authorizing local option elections to legalize or prohibit the operation of eight-liners.

HJR 129 Thompson, Senfronia | et al.  
Proposing a constitutional amendment authorizing the Ysleta del Sur Pueblo Tribe and the Alabama-Coushatta Tribe of Texas to conduct all forms of gaming on certain tribal land and requiring the tribes to annually pay five percent of net proceeds from gaming to the comptroller of public accounts for deposit in the general revenue fund.

HJR 142 Deshotel  
Proposing a constitutional amendment authorizing the operation of casino games in certain areas of this state by licensed persons to provide additional money for residual windstorm insurance coverage in the coastal areas; providing for certification or licensing of persons engaged in occupations related to casino gaming.
