BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF TEXAS:

5 SECTION 1. Section 552.221, Government Code, is amended by 6 adding Subsections (b-1) and (b-2) to read as follows:

(b-1) In addition to the methods of production described by 7 Subsection (b), an officer for public information for a political 8 subdivision of this state complies with Subsection (a) by referring 9 10 a requestor to an exact Internet location or uniform resource 11 locator (URL) address on a website maintained by the political subdivision and accessible to the public if the requested 12 information is identifiable and readily available on that website. 13 If the person requesting the information prefers a manner other 14 than access through the URL, the political subdivision, 15 notwithstanding any other provision of this chapter, must supply 16 17 the information by:

18 (1) providing the public information for inspection or 19 duplication in the offices of the governmental body; or

20 (2) sending printed copies of the public information 21 by first class United States mail if the person requesting the 22 information requests that copies be provided and pays the postage 23 and any other applicable charges that the requestor has accrued 24 under Subchapter F.

1 (b-2) If an officer for public information for a political 2 subdivision provides by e-mail an Internet location or uniform 3 resource locator (URL) address as permitted by Subsection (b-1), 4 the e-mail must contain a statement in a conspicuous font clearly 5 indicating that the requestor may nonetheless access the requested 6 information by inspection or duplication or by receipt through 7 United States mail, as provided by Subsection (b-1).

8 SECTION 2. Section 182.052, Utilities Code, is amended by 9 adding Subsection (e) to read as follows:

10 (e) A governmental body as defined by Section 552.003, 11 Government Code, may withhold information prohibited from being 12 disclosed under this section without the necessity of requesting a 13 decision from the attorney general under Subchapter G, Chapter 552, 14 Government Code.

15 SECTION 3. The changes in law made by this Act apply only to 16 a request for information that is received by a governmental body or 17 an officer for public information on or after the effective date of 18 this Act. A request for information that was received before the 19 effective date of this Act is governed by the law in effect on the 20 date the request was received, and the former law is continued in 21 effect for that purpose.
