H.B. No. 830

A BILL TO BE ENTITLED

AN ACT

relating to the issuance of Alamo specialty license plates.

BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF TEXAS:

SECTION 1. Subchapter G, Chapter 504, Transportation Code, is amended by adding Section 504.665 to read as follows:

Sec. 504.665. ALAMO LICENSE PLATES. (a) The department shall issue specialty license plates that include the image of the Alamo and the word "Remember" at the bottom of each plate.

(b) After deduction of the department's administrative costs, the remainder of the fee for issuance of the license plates shall be deposited to the credit of an account created by the comptroller in the manner provided by Section 504.6012(b). Money deposited to that account may be used only by the General Land Office as follows:

(1) 75 percent of the money shall be used for the preservation of the Alamo; and

(2) 25 percent of the money shall be used to enhance the Alamo visitor experience or to fund education programs about the Alamo.

SECTION 2. This Act takes effect September 1, 2015.

"Remember." The bill would require the DMV to design the license plate in consultation with the Daughters of the Republic of Texas. The bill would specify that the fee for the new specialty license plate, after deduction of DMV administrative costs, is to be deposited to the credit of an account in the license plate trust fund created by the Comptroller. The bill would authorize money deposited to the account to be used only by the Texas Historical Commission to provide grants to benefit the Alamo Mission Chapter of the Daughters of the Republic of Texas to fund Texas history education programs.

The bill would take effect on September 1, 2015.

Methodology

Based on the information and analysis provided by the DMV, this analysis assumes 200 of the new specialty license plates would be issued each year at a fee of \$30 each of which \$7.50 would be deposited to the General Revenue Fund for DMV administrative expenses; \$0.50 would be retained by the counties; and \$22 would be deposited to an account in the License Plate Trust Fund in the in the treasury and may be appropriated to the Texas Historical Commission (THC) to provide grants.

Based on the analysis of the DMV and THC, it is assumed any costs or duties associated with implementing the provisions of the bill could be absorbed within existing resources.
