- 8 renovates plumbing or supervises any of those activities under the
- 9 supervision of a responsible master plumber;
- 10 (D) has passed the required examination; and
- 11 (E) has fulfilled the other requirements of the
- 12 board.
- SECTION 2. Section 1301.354(c), Occupations Code, is
- 14 amended to read as follows:
- 15 (c) At the applicant's request, the board may credit an
- 16 applicant under Subsection (b) with up to 1,000 [500] hours of the
- 17 work experience required before taking an examination if the
- 18 applicant has completed the classroom portion of a training
- 19 program:
- 20 (1) approved by the United States Department of Labor,
- 21 Office of Apprenticeship; or
- 22 (2) provided by a person approved by the board and
- 23 based on course materials approved by the board.

- (c) The change in law made by this Act applies only to an application for a license as a journeyman plumber submitted on or after the effective date of this Act. An application for a license submitted before the effective date of this Act is governed by the
