| 9 | Sec. 327.001. DEFINITIONS. In this chapter: |
| 10 | (1) "Committee" means the Joint Committee to Review |
| 11 | the Sunset Advisory Commission. |
| 12 | (2) "Executive head of a state agency" means the |
| 13 | director, executive director, commissioner, administrator, chief |
| 14 | clerk, or other individual who is appointed by the governing body or |
| 15 | highest officer of the state agency to act as the chief executive or |
| 16 | administrative officer of the agency. |
| 17 | Sec. 327.002. JOINT COMMITTEE TO REVIEW THE SUNSET ADVISORY |
| 18 | COMMISSION. (a) The Joint Committee to Review the Sunset Advisory |
| 19 | Commission consists of: |
| 20 | (1) three members of the senate and one public member |
| 21 | appointed by the lieutenant governor; |
| 22 | (2) three members of the house of representatives and |
| 23 | one public member appointed by the speaker of the house; and |
| 24 | (3) two executive heads of state agencies and one |

1 public member appointed by the governor. 2 The lieutenant governor and the speaker of the house may (b) 3 serve as one of the legislative appointees. 4 (c) A public member of the committee may not concurrently be 5 serving as a member of the Sunset Advisory Commission. 6 (d) Not more than one legislative member of the committee 7 from each house may concurrently be serving as a member of the 8 Sunset Advisory Commission. 9 (e) If a vacancy occurs, the appropriate appointing 10 authority shall appoint a person to serve for the remainder of the unexpired term in the same manner as the original appointment. 11 12 (f) The lieutenant governor shall designate one of the committee members appointed by the lieutenant governor to serve as 13 joint chair of the committee. The speaker of the house of 14 15 representatives shall designate one of the committee members appointed by the speaker to serve as joint chair of the committee. 16 17 (g) Each member of the committee is entitled to reimbursement for actual and necessary expenses incurred in 18 19 performing committee duties. Each legislative member is entitled to reimbursement from the appropriate fund of the member's respective 20 house. Each public member and committee member appointed by the 21 22 governor is entitled to reimbursement from funds appropriated to 23 the committee. 24 Sec. 327.003. STAFF. The committee shall employ persons 25 necessary to carry out this chapter through funds made available by 26 the legislature. 27 Sec. 327.004. COMMITTEE DUTIES. Before December 1, 2018,

1 the committee shall consider whether a public need exists for the 2 continuation of the Sunset Advisory Commission. In making the determination, the committee shall consider: 3 4 (1) the efficiency and effectiveness with which the commission operates, including the cost of maintaining the 5 commission and its staff as well as any savings realized by the work 6 7 of the commission; 8 (2) the mission and goals intended for the commission and the problem or need that the commission was intended to address; 9 (3) the extent to which the commission's mission and 10 goals have been achieved and the problem or need has been addressed; 11 12 (4) the commission's activities that are authorized by statute and any other commission activity and authority for those 13 14 activities and the extent to which those activities are needed; 15 (5) whether less restrictive or alternative methods of performing any function that the commission performs could 16 17 adequately protect or provide service to the public; and (6) an assessment of the commission's rulemaking 18 processes, including the extent to which the commission has 19 encouraged participation by the public in making its decisions and 20 the extent to which public participation has resulted in rules that 21 22 benefit the public. 23 Sec. 327.005. REPORT TO LEGISLATURE. (a) Not later than 24 December 1, 2018, the committee shall report its findings to the 25 legislature. 26 (b) In its report to the legislature, the committee shall 27 make recommendations:

1 (1) on the abolishment, continuation, or reorganization of the Sunset Advisory Commission and on the need 2 3 for the performance of the functions of the commission; and 4 (2) to improve the operations of the Sunset Advisory 5 Commission and its governing body, including management recommendations that do not require a change in the commission's 6 7 enabling statute. 8 (c) The committee shall include the estimated fiscal impact of its recommendations and may recommend appropriation levels for 9 10 the Sunset Advisory Commission. Sec. 327.006. SUBPOENA POWER. (a) The committee may issue 11 12 process to compel the attendance of witnesses and the production of books, records, papers, and other objects necessary or proper for 13 the purposes of the committee proceedings. The process may be 14 15 served on a witness at any place in this state. 16 (b) If a majority of the committee directs the issuance of a 17 subpoena, a joint chair shall issue the subpoena in the name of the 18 committee. 19 (c) If both joint chairs are absent, a designee of one of the joint chairs may issue a subpoena or other process in the same 20 21 manner as the joint chair. (d) If necessary to obtain compliance with a subpoena or 22 other process, the committee may issue attachments. 23 The 24 attachments may be addressed to and served by any peace officer in 25 this state. 26 (e) Testimony taken under subpoena must be reduced to writing and given under oath subject to the penalties of perjury. 27

22 Sec. 327.009. EXPIRATION. This chapter expires January 1, 23 2019.

24 SECTION 2. This Act takes effect immediately if it receives 25 a vote of two-thirds of all the members elected to each house, as 26 provided by Section 39, Article III, Texas Constitution. If this 27 Act does not receive the vote necessary for immediate effect, this
