## RESOLUTION

WHEREAS, The city of Lubbock lost a venerated entrepreneur
and philanthropist with the passing of Bobbie Ray Griffin on June 7,
2017, at the age of 87; and

WHEREAS, Born in Matador at the height of the Great 4 5 Depression, "Rip" Griffin learned the value of hard work at a young age through a series of jobs that included delivering newspapers 6 7 and driving a truck; he graduated from Lubbock High School in 1948 and subsequently played semiprofessional baseball in a traveling 8 9 oil league, and he continued in the sport while serving his country for four years as a member of the United States Army; following his 10 11 honorable discharge in 1953, he enrolled at Texas Tech University, 12 where he earned a bachelor's degree in business administration in 1955; while a student, he kept the books for a trailer company and 13 14 transported gasoline; and

15 WHEREAS, After college, Mr. Griffin worked for Texaco before 16 opening his first truck stop in Lubbock in 1962; two years later, he 17 founded the Rip Griffin Truck Service Center, and he eventually 18 expanded the business to include not only a chain of truck stops 19 across the western United States but also a number of truck 20 dealerships; in 1989, he ventured into wholesale fuel storage and 21 transportation with the establishment of Pro Petroleum; and

22 WHEREAS, Believing deeply in the value of both education and 23 sports, Mr. Griffin gave freely of his time and resources in behalf 24 of Lubbock Christian University, on whose board of trustees he

1 served for 42 years, and Texas Tech University; his loyal support 2 was recognized with the dedication of the Rip Griffin Center by LCU 3 in 2000 and Rip Griffin Park by Tech in 2012; he was also a faithful 4 sponsor of the Lubbock Hubbers professional baseball club and a 5 staunch advocate of the Children's Home of Lubbock and the Boys & 6 Girls Club of Lubbock, which inducted him into its Alumni Hall of 7 Fame in 2009; and

8 WHEREAS, Mr. Griffin was a devoted husband to his wife, 9 Geneva, and over the decades, their union was blessed with 5 10 children, David, Mark, Julie, Jill, and Suzanne, as well as 14 11 grandchildren and 8 great-grandchildren; and

12 WHEREAS, A man of great warmth, humility, and generosity, Rip 13 Griffin left an indelible imprint on Lubbock and touched the lives 14 of countless fellow citizens, and those who were fortunate enough 15 to share in his love and friendship will forever hold him close in 16 their hearts; now, therefore, be it
