1 WHEREAS, Family and friends will long cherish their memories
2 of Donald Lewis Benton of El Paso, who passed away on July 18, 2017,
3 at the age of 80; and

4 WHEREAS, The son of Freida Ivey and Lewis Benton, Donald
5 Benton was born on December 29, 1936, and he was raised by his
6 grandparents, Mr. and Mrs. R. C. Ivey, in Fabens; he graduated from
7 New Mexico Military Institute before continuing his education at
8 Texas Tech University and Sul Ross State University, where he
9 earned his bachelor of science and master of engineering degrees;
10 he completed a second master's degree at Sam Houston State
11 University, and he answered his nation's call to duty as a member of
12 the United States Army; during his two years of military service, he
13 was assigned to work in bioacoustic research at the Walter Reed Army
14 Medical Center in Washington, D.C.; and

15 WHEREAS, After returning to civilian life, Mr. Benton worked
16 as a teacher and coach in Fort Hancock, Tornillo, Socorro, and
17 Clint, and he was admired by his students for his enthusiasm and
18 sense of humor; and

19 WHEREAS, In all his endeavors, Mr. Benton enjoyed the love
20 and support of his wife, Betty, and their treasured family, which
21 included his three daughters, Penny, Brenda, and Wray, and his four
22 stepchildren, Shawndi, Stacy, Shelly, and Scott; his life was
23 further enriched by his nine grandchildren and two
24 great-grandchildren; in his leisure hours, he was fond of fishing,

1 hunting, and spending time at his lake house at Elephant Butte; a
2 member of the Masons for more than five decades, he held the title
3 of Worshipful Master at his local lodge from 2006 to 2009 and also
4 belonged to the Grand Scottish Rite and the Grand Lodge of Texas;

7 although he will be greatly missed, he will always be remembered
8 with deep affection by those who had the good fortune to know him;
