1 WHEREAS, Proud members of the University of North Texas at
2 Dallas community are gathering on August 3, 2017, to celebrate the
3 ribbon-cutting ceremony for the school's first residence facility,
4 University Hall; and

5 WHEREAS, The handsome 27,000-square-foot, 120-bed dormitory
6 includes 96 single-occupancy rooms and 12 double-occupancy rooms on
7 four floors, each of which will be staffed by a resident advisor;
8 this state-of-the-art building also offers UNT students high-speed
9 Internet, DirecTV, large study areas, and multipurpose spaces for
10 classes and workshops, as well as a kitchen, a social area, and a
11 workout room; and

12 WHEREAS, The new residence hall will help foster networking
13 and a sense of community among UNT students, and during the summer,
14 the building will be available for participants in summer camps and
15 sports clinics; the first of two new buildings on the UNT Dallas
16 campus, it is part of an exciting expansion project that will
17 include a Student Access and Success Center and an open-air
18 amphitheater; and

19 WHEREAS, Welcoming its first residents in August 2017,
20 University Hall will contribute to advancing the university's vital
21 mission and to strengthening its connection to South Dallas and the
22 surrounding area; now, therefore, be it
