1 WHEREAS, The Roma Middle School Symphonic Winds ensemble
2 earned the distinction of performing at the 70th annual Midwest
3 Clinic International Band, Orchestra and Music Conference, held in
4 Chicago in December 2016; and

5 WHEREAS, Established in 1946, the Midwest Clinic is a
6 prestigious international conference dedicated to helping
7 musicians of all skill levels advance to the next stage of their
8 careers; it annually draws more than 17,000 attendees from all 50
9 states and over 30 countries and features concerts from ensembles
10 representing a broad range of age groups; selection to perform at
11 the conference is an honor accorded to only a handful of groups and
12 is based largely on performance recordings submitted as part of the
13 application process; and

14 WHEREAS, One of just four middle school bands in the world
15 chosen to perform at the conference in 2016, the Roma ensemble
16 played before an audience of some 2,000 people on December 15; the
17 group is the first concert band from the Rio Grande Valley to be
18 asked to perform at the event since 1952, as well as the first
19 middle school band from South Texas ever to be invited; and

20 WHEREAS, Benefiting from the skillful guidance of head
21 director Corey L. Graves, this exceptional group is composed of
