## RESOLUTION

1 WHEREAS, The city of College Station lost a greatly admired 2 citizen with the passing of oilman and philanthropist Emil Eugene 3 Ogden on July 25, 2017, at the age of 89; and WHEREAS, Born in Blackwell, Oklahoma, on September 15, 1927, 4 5 Emil Ogden was the only son of Homer and Mary Ogden; his childhood was marked by hardship, and those early experiences played a part in 6 shaping the character and resolve that would contribute to his 7 success in later life; he served his country in World War II, and he 8 went on to play minor league baseball for the Odessa Oilers before 9 setting out to make a living for himself in the oil fields; and 10 11 WHEREAS, Mr. Ogden was an independent oilman in Abilene for 12 28 years; beginning his career as a wildcatter, he supplemented his income by coaching junior high basketball and playing the trumpet 13 14 in a big band orchestra to make ends meet; his determination sustained him through the "boom and bust" cycle, and after moving to 15 Bryan-College Station in 1979, he was instrumental in developing 16 the Bryan Woodbine Field, one of the most significant oil 17 discoveries in Texas in the 1980s; along the way, he won the 18 loyalty, respect, and affection of numerous associates 19 and 20 employees, some of whom became his lifelong friends; and 21 WHEREAS, Despite his fortune, Mr. Ogden never lost sight of 22 his humble roots, and he gave generously to a variety of organizations benefiting citizens in need; he also actively 23

volunteered his time in leadership positions, which included

- 2 County Sheriff's Office, as president of the West Texas Oil & Gas
- 3 Association, as an Abilene City Council member, and in numerous
- 4 other board and committee positions; his Catholic faith was a
- 5 central pillar of his life, and he dedicated a great deal of his
- 6 time and resources to the St. Thomas Aquinas Parish; and
- 7 WHEREAS, A man who exemplified the values of hard work and
- 8 perseverance, Emil Ogden leaves behind a record of service that
- 9 will long resonate in the community and that his loved ones can
- 10 remember with pride; now, therefore, be it
