- 24 of four children, Tremeka Devo, Shimiere Turner, Tiffany Turner,

- 2 and to Endiya and Brayden Devo; a man of strong religious faith,
- 3 Trooper Black is also active in his church; and
- WHEREAS, Michael Black's expertise, professionalism, and
- 5 devotion to the core values of the DPS have greatly benefited the
- 6 citizens of Texas, and he may indeed reflect with pride on a career
- 7 well spent as he embarks on the next exciting chapter of his life;

- 10 Legislature, 1st Called Session, hereby congratulate Senior
- 11 Trooper Michael A. Black on his retirement from the Texas
