RESOLUTION

1 WHEREAS, Camille D. Miller of Austin is retiring as president 2 and chief executive officer of the Texas Health Institute on 3 September 16, 2017, concluding a 22-year tenure at the helm of the 4 agency and drawing to a close four decades of service to her fellow 5 Texans; and

6 WHEREAS, A graduate of The University of Texas at Austin, 7 Ms. Miller holds a bachelor's degree in sociology and a master's degree in social work; she was hired by Governor Preston Smith's 8 office in 1970 as a statistician in the Division of Planning 9 Coordination, and she became director of plans and research during 10 11 the Dolph Briscoe administration; subsequently, she joined the 12 Manpower Services Division in the Texas Department of Community Affairs and was its assistant director before becoming a partner in 13 14 Dimension Associates, a private consulting firm; and

WHEREAS, Ms. Miller returned to state government in 1982 and 15 16 rose to become director of policy and research in the office of the lieutenant governor under William P. Hobby; later, she served with 17 Bob Bullock in both the office of the comptroller and the office of 18 the lieutenant governor; she briefly led the newly created Texas 19 Department of Protective and Regulatory Affairs as 20 interim 21 executive director in the early 1990s and then served as chief of 22 staff for Senator Judith Zaffirini at the Senate Committee on 23 Health and Human Services; and

24 WHEREAS, In 1995, Ms. Miller became Medicaid Project

1 director for the Texas Hospital Association, and she took on leadership of the Texas Institute for Health Policy Research the 2 3 following year; she has served her profession in numerous capacities, among them chair of the National Network of Public 4 5 Health Institutes and the National State Health Policy Centers Collaborative, and her many accolades include lifetime achievement 6 awards from both the National Association of Social Workers and its 7 Texas chapter and an honorary doctorate in public service from the 8 board of regents of the University of North Texas Health Science 9 10 Center; and

11 WHEREAS, Camille Miller has made a lasting, positive 12 difference in many lives through her outstanding contributions in 13 public service and public policy, and she may indeed take pride in a 14 career well spent; now, therefore, be it

15 RESOLVED, That the House of Representatives of the 85th Texas 16 Legislature, 1st Called Session, hereby congratulate Camille 17 Miller on her retirement as president and CEO of the Texas Health 18 Institute and extend to her sincere best wishes for the future; and, 19 be it further

20 RESOLVED, That an official copy of this resolution be 21 prepared for Ms. Miller as an expression of high regard by the Texas 22 House of Representatives.
