1-17 A BILL TO BE ENTITLED
 1-18 AN ACT

1-19 relating to the continuation and sunset review of certain
 1-20 governmental entities subject to abolishment on September 1, 2017.

1-21 BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF TEXAS:

1-22 SECTION 1. Section 151.004, Occupations Code, is amended to
 1-23 read as follows:

1-24 Sec. 151.004. APPLICATION OF SUNSET ACT. The Texas Medical
 1-25 Board is subject to Chapter 325, Government Code (Texas Sunset
 1-26 Act). Unless continued in existence as provided by that chapter,
 1-27 the board is abolished and this subtitle and Chapters 204, 205, 206,
 1-28 601, 602, 603, and 604 expire September 1, 2019 [2017].

1-29 SECTION 2. Section 501.005, Occupations Code, is amended to
 1-30 read as follows:

1-31 Sec. 501.005. APPLICATION OF SUNSET ACT. The Texas State
 1-32 Board of Examiners of Psychologists is subject to Chapter 325,
 1-33 Government Code (Texas Sunset Act). Unless continued in existence
 1-34 as provided by that chapter, the board is abolished and this chapter
 1-35 expires September 1, 2019 [2017].

1-36 SECTION 3. Section 502.003, Occupations Code, is amended to
 1-37 read as follows:

1-38 Sec. 502.003. APPLICATION OF SUNSET ACT. The Texas State
 1-39 Board of Examiners of Marriage and Family Therapists is subject to
 1-40 Chapter 325, Government Code (Texas Sunset Act). Unless continued
 1-41 in existence as provided by that chapter, the board is abolished and
 1-42 this chapter expires September 1, 2019 [2017].

1-43 SECTION 4. Section 503.005, Occupations Code, is amended to
 1-44 read as follows:

1-45 Sec. 503.005. APPLICATION OF SUNSET ACT. The Texas State
 1-46 Board of Examiners of Professional Counselors is subject to Chapter
 1-47 325, Government Code (Texas Sunset Act). Unless continued in
 1-48 existence as provided by that chapter, the board is abolished
 1-49 September 1, 2019 [2017].

1-50 SECTION 5. Section 505.005, Occupations Code, is amended to
 1-51 read as follows:

1-52 Sec. 505.005. APPLICATION OF SUNSET ACT. The Texas State
 1-53 Board of Social Worker Examiners is subject to Chapter 325,
 1-54 Government Code (Texas Sunset Act). Unless continued in existence
 1-55 as provided by that chapter, the board is abolished and Section
 1-56 505.101 expires September 1, 2019 [2017].

1-57 SECTION 6. Chapter 325, Government Code, is amended by
 1-58 adding Section 325.0128 to read as follows:

1-59 Sec. 325.0128. AGENCIES REVIEWED FOR 85TH LEGISLATURE. For
 1-60 a state agency that was reviewed by the commission in preparation
 1-61 for the work of the 85th Legislature in Regular Session and the

2-1 abolition date of which was extended to 2019, the commission shall
2-2 limit its review of the agency in preparation for the work of the
2-3 86th Legislature in Regular Session to the appropriateness of
2-4 recommendations made by the commission to the 85th Legislature. In
2-5 the commission's report to the 86th Legislature, the commission may
2-6 include any recommendations it considers appropriate. This section
2-7 expires September 1, 2019.

2-8 SECTION 7. This Act takes effect immediately if it receives
2-9 a vote of two-thirds of all the members elected to each house, as
2-10 provided by Section 39, Article III, Texas Constitution. If this
2-11 Act does not receive the vote necessary for immediate effect, this
2-12 Act takes effect on the 91st day after the last day of the
2-13 legislative session.
