- 9 Agriculture is subject to Chapter 325, Government Code (Texas
- 10 Sunset Act). Unless continued in existence as provided by that
- 11 chapter, the department is abolished September 1, 2019 [2021].
- 12 ARTICLE 2. ENTITIES GIVEN 2021 SUNSET DATE
- 13 SECTION 2.01. TEXAS HISTORICAL COMMISSION. Section
- 14 442.002(k), Government Code, is amended to read as follows:
- 15 (k) The Texas Historical Commission is subject to Chapter
- 16 325 (Texas Sunset Act). Unless continued in existence as provided
- 17 by that chapter, the commission is abolished and this chapter
- 18 expires September 1, 2021 [2019].
- 19 SECTION 2.02. TEXAS REAL ESTATE COMMISSION. Section
- 20 1101.006, Occupations Code, is amended to read as follows:
- Sec. 1101.006. APPLICATION OF SUNSET ACT. The Texas Real
- 22 Estate Commission is subject to Chapter 325, Government Code (Texas
- 23 Sunset Act). Unless continued in existence as provided by that
- 24 chapter, the commission is abolished and this chapter, Chapter

- 2 SECTION 3.01. TEXAS MILITARY DEPARTMENT. Section 437.051,
- 3 Government Code, is amended to read as follows:
- 4 Sec. 437.051. SUNSET PROVISION. The department is subject
- 5 to Chapter 325 (Texas Sunset Act). Unless continued in existence as
- 6 provided by that chapter, the department is abolished and this
- 7 subchapter expires September 1, 2023 [2019].
- 8 SECTION 3.02. TEXAS STATE LIBRARY AND ARCHIVES COMMISSION.
- 9 Section 441.001(q), Government Code, is amended to read as follows:
- 10 (q) The Texas State Library and Archives Commission is
- 11 subject to Chapter 325 (Texas Sunset Act). Unless continued in
- 12 existence as provided by that chapter, the commission is abolished
- 13 September 1, 2023 [2019].
- 14 SECTION 3.03. TEXAS STATE BOARD OF PUBLIC ACCOUNTANCY.
- 15 Section 901.006, Occupations Code, is amended to read as follows:
- 16 Sec. 901.006. APPLICATION OF SUNSET ACT. The Texas State
- 17 Board of Public Accountancy is subject to Chapter 325, Government
- 18 Code (Texas Sunset Act). Unless continued in existence as provided
- 19 by that chapter, the board is abolished and this chapter expires
- 20 September 1, 2023 [2019].
- 21 SECTION 3.04. STATE SECURITIES BOARD. Subsection O,
- 22 Section 2, The Securities Act (Article 581-2, Vernon's Texas Civil
- 23 Statutes), is amended to read as follows:
- O. The State Securities Board is subject to Chapter 325,
- 25 Government Code (Texas Sunset Act). Unless continued in existence
- 26 as provided by that chapter, the board is abolished and this Act
- 27 expires September 1, 2023 [2019].

1 ARTICLE 4. EFFECTIVE DATE

SECTION 4.01. EFFECTIVE DATE. This Act takes effect immediately if it receives a vote of two-thirds of all the members elected to each house, as provided by Section 39, Article III, Texas Constitution. If this Act does not receive the vote necessary for immediate effect, this Act takes effect on the 91st day after the last day of the legislative session.
