- 5 ARTICLE 1. ENTITIES GIVEN 2021 SUNSET DATE
- 6 SECTION 1.01. TEXAS HISTORICAL COMMISSION. Section
- 7 442.002(k), Government Code, is amended to read as follows:
- 8 (k) The Texas Historical Commission is subject to Chapter
- 9 325 (Texas Sunset Act). Unless continued in existence as provided
- 10 by that chapter, the commission is abolished and this chapter
- 11 expires September 1, 2021 [2019].
- 12 SECTION 1.02. TEXAS STATE BOARD OF PLUMBING EXAMINERS.
- 13 Section 1301.003, Occupations Code, is amended to read as follows:
- 14 Sec. 1301.003. APPLICATION OF SUNSET ACT. The Texas State
- 15 Board of Plumbing Examiners is subject to Chapter 325, Government
- 16 Code (Texas Sunset Act). Unless continued in existence as provided
- 17 by that chapter, the board is abolished and this chapter expires
- 18 September 1, 2021 [2019].
- 19 ARTICLE 2. ENTITIES GIVEN 2023 SUNSET DATE
- SECTION 2.01. TEXAS MILITARY DEPARTMENT. Section 437.051,
- 21 Government Code, is amended to read as follows:
- Sec. 437.051. SUNSET PROVISION. The department is subject
- 23 to Chapter 325 (Texas Sunset Act). Unless continued in existence as
- 24 provided by that chapter, the department is abolished and this

- 1 subchapter expires September 1, 2023 [2019].
- 2 SECTION 2.02. TEXAS STATE LIBRARY AND ARCHIVES COMMISSION.
- 3 Section 441.001(q), Government Code, is amended to read as follows:
- 4 (q) The Texas State Library and Archives Commission is
- 5 subject to Chapter 325 (Texas Sunset Act). Unless continued in
- 6 existence as provided by that chapter, the commission is abolished
- 7 September 1, 2023 [2019].
- 8 SECTION 2.03. TEXAS DEPARTMENT OF MOTOR VEHICLES. Section
- 9 1001.005, Transportation Code, is amended to read as follows:
- Sec. 1001.005. SUNSET PROVISION. The department is subject
- 11 to Chapter 325, Government Code (Texas Sunset Act). Unless
- 12 continued in existence as provided by that chapter, the department
- is abolished September 1, 2023 $\left[\frac{2019}{2}\right]$.
- 14 ARTICLE 3. EFFECTIVE DATE
- 15 SECTION 3.01. EFFECTIVE DATE. This Act takes effect
- 16 immediately if it receives a vote of two-thirds of all the members
- 17 elected to each house, as provided by Section 39, Article III, Texas
- 18 Constitution. If this Act does not receive the vote necessary for
- 19 immediate effect, this Act takes effect on the 91st day after the
- 20 last day of the legislative session.
