Re: Responsibility of the Texas Commission on Environmental Quality (TCEQ) Pursuant to Article XVI, Section 59(d), Texas Constitution

House Bill (HB) 1186, as Filed by Representative Rodney Anderson - Relating to the procedure for claiming an exemption from ad valorem taxation by the Dallas County Utility and Reclamation District of certain property subject to a tax abatement agreement with the district and to the validation of certain actions of the district.

Dear Speaker Straus:

The following comments are provided pursuant to the Constitutional requirements referenced above. Under those requirements, the TCEQ must submit, to the Governor, Lieutenant Governor and Speaker of the House of Representatives, the TCEQ's recommendations on specific legislation affecting water districts. We recommend that these comments be considered in the evaluation of the proposed legislation.

The bill amends Section 4B, Chapter 628, Acts of the 68<sup>th</sup> Legislature, Regular Session, 1983 regarding Dallas County Utility and Reclamation District (District) by adding Subdivision 16 which specifies that the tax assessor-collector for the District or a person designated by the tax assessor-collector may file an application for the exemption on behalf of the property owner with the chief appraiser for the appraisal district in which the property is located if the District enters into a tax abatement agreement with the owner of a single-family residential property to exempt a portion of the taxable value of the property from taxation. This bill is a duplicate of House Bill 549 filed by Representative Rodney Anderson (Dallas).


