House Bill (HB) 2363, as Filed by Representative Poncho Nevárez-relating to export fees charged by the Middle Pecos Groundwater Conservation District; changing a fee.

Dear Speaker Straus:

The following comments are provided pursuant to the Constitutional requirements referenced above. Under those requirements, the TCEQ must submit, to the Governor, Lieutenant Governor and Speaker of the House of Representatives, the TCEQ's recommendations on specific legislation affecting water districts. We recommend that these comments be considered in the evaluation of the proposed legislation.

The bill amends Special District Local Laws Code §8851, Middle Pecos Groundwater Conservation District, in Pecos County. The bill proposes that if a production fee is assessed, a fee for transport of groundwater outside of the District may also be assessed.
