Re: Responsibility of the Texas Commission on Environmental Quality (TCEQ) Pursuant to Article XVI, Section 59(d), Texas Constitution.

House Bill (HB) 2364, as Filed by Representative Poncho Nevárez-relating to the disqualification of directors of the Middle Pecos Groundwater Conservation District.

Dear Speaker Straus:

The following comments are provided pursuant to the Constitutional requirements referenced above. Under those requirements, the TCEQ must submit, to the Governor, Lieutenant Governor and Speaker of the House of Representatives, the TCEQ's recommendations on specific legislation affecting water districts. We recommend that these comments be considered in the evaluation of the proposed legislation.

The bill amends Special District Local Laws Code §8851, Middle Pecos Groundwater Conservation District, in Pecos County. The bill provides that the District's Board of Directors may remove a director only if that director has missed one-half or more of the regular meetings scheduled during the prior 12 months. A unanimous decision among the remaining members of the District's board is required for director removal.
