Amend CSHB 2962 (house committee printing) as follows:

(1) On page 2, lines 1-2, between "<u>to</u>" and "<u>a health care</u> <u>facility</u>", insert the following:

:

(1) a physician who performs an abortion at an abortion facility if the abortion results in an abortion complication that is diagnosed or treated by that physician or at the abortion facility; or

(2)

(2) On page 2, line 6, between "<u>(c)</u>" and "<u>Each</u>", insert the following:

A physician described by Subsection (b)(1) shall submit to the department in the form and manner prescribed by department rule a report on each abortion complication diagnosed or treated by that physician or at the abortion facility not later than 72 hours after the complication is diagnosed or treated.

(3) On page 2, line 6, strike "<u>Subsection (b) shall submit</u>" and substitute "<u>Subsection (b)(2) shall electronically submit</u>".

(4) On page 2, line 14, between "<u>abortion</u>" and "<u>or</u>", insert
", other than a physician described by Subsection (b)(1),".

(5) On page 2, line 15, between "<u>identify</u>" and "<u>the</u>", insert "<u>the name of the physician submitting the report or</u>".

(6) On page 3, between lines 4 and 5, add the following appropriately numbered subdivisions to added Section 171.006(f), Health and Safety Code, and renumbering subdivisions of that subsection and references to those subdivisions accordingly:

(____) the patient's year of birth, race, marital status, and state and county of residence;

(____) the date of the first day of the patient's last menstrual period that occurred before the date of the abortion that caused or may have caused the complication;

(7) On page 4, line 3, between "<u>A</u>" and "<u>facility</u>", insert "<u>physician described by Subsection (b)(1) or</u>".

(8) On page 4, line 5, between "<u>department</u>" and the underlined comma, insert "<u>or appropriate licensing agency</u>".

(9) On page 4, line 10, between "<u>a</u>" and "<u>facility's</u>", insert "<u>physician's or</u>".

(10) On page 4, line 12, between "<u>the</u>" and "<u>facility</u>", insert "<u>physician or</u>".

(11) On page 4, line 13, strike "<u>department</u>" and substitute "<u>appropriate licensing agency</u>".

(12) On page 4, between lines 13 and 14, add the following appropriately lettered subsection:

(____) The department shall notify the Texas Medical Board of any violations of this section by a physician.

(13) Add the following appropriately numbered SECTION to the bill and renumber SECTIONS of the bill accordingly:

SECTION _____. The Department of State Health Services shall establish an electronic reporting system for purposes of Section 171.006, Health and Safety Code, as added by this Act, as soon as practicable after the effective date of this Act.
