BILL ANALYSIS

C.S.H.B. 106 By: Martinez, "Mando" Homeland Security & Public Safety Committee Report (Substituted)

BACKGROUND AND PURPOSE

Concerns have been raised that state law currently treats property and persons near the border in an inequitable manner by permitting the use of unmanned aircraft in Texas to capture images of real property or persons on real property that are within 25 miles of the United States border. C.S.H.B. 106 seeks to address these concerns by removing the capturing of such images from the lawful uses of unmanned aircraft in Texas and provides that telecommunications providers are subject to the same rules in this regard as those governing other utilities.

CRIMINAL JUSTICE IMPACT

It is the committee's opinion that this bill does not expressly create a criminal offense, increase the punishment for an existing criminal offense or category of offenses, or change the eligibility of a person for community supervision, parole, or mandatory supervision.

RULEMAKING AUTHORITY

It is the committee's opinion that this bill does not expressly grant any additional rulemaking authority to a state officer, department, agency, or institution.

ANALYSIS

C.S.H.B. 106 amends the Government Code to remove as a lawful use of an unmanned aircraft in Texas the capturing of an image of real property or a person on real property that is within 25 miles of the United States border. The bill makes the capturing of an image using such an aircraft by or for a telecommunications provider lawful to the same extent and for the same purposes as an image captured by or for an electric or natural gas utility.

EFFECTIVE DATE

September 1, 2017.

COMPARISON OF ORIGINAL AND SUBSTITUTE

While C.S.H.B. 106 may differ from the original in minor or nonsubstantive ways, the following comparison is organized and formatted in a manner that indicates the substantial differences between the introduced and committee substitute versions of the bill.

(19) [(20)] if the image is captured by a registered professional land surveyor in connection with the practice of professional surveying, as those terms are defined by Section 1071.002, Occupations Code, provided that no individual is identifiable in the image; or

(20) [(21)] if the image is captured by a professional engineer licensed under Subchapter G, Chapter 1001, Occupations Code, in connection with the practice of engineering, as defined by Section 1001.003, Occupations Code, provided that no individual is identifiable in the image.

SECTION 2. The change in law made by this Act applies only to an offense committed on or after the effective date of this Act. An offense committed before the effective date of this Act is governed by the law in effect on the date the offense was committed, and the former law is continued in effect for that purpose. For purposes of this section, an offense was committed before the effective date of this Act if any element of the offense occurred before that date.

SECTION 3. This Act takes effect September 1, 2017.
