BILL ANALYSIS

C.S.H.B. 491 By: Frullo Criminal Jurisprudence Committee Report (Substituted)

BACKGROUND AND PURPOSE

Interested parties contend that individuals convicted of certain continuous trafficking of persons offenses should be required to register as sex offenders for life to bring the requirements for these offenders in line with requirements for similar or even less grievous offenders who are subject to sex offender registration. C.S.H.B. 491 seeks to address this issue by including certain continuous trafficking of persons offenders among the required registrants of the sex offender registration program.

CRIMINAL JUSTICE IMPACT

It is the committee's opinion that this bill does not expressly create a criminal offense, increase the punishment for an existing criminal offense or category of offenses, or change the eligibility of a person for community supervision, parole, or mandatory supervision.

RULEMAKING AUTHORITY

It is the committee's opinion that this bill does not expressly grant any additional rulemaking authority to a state officer, department, agency, or institution.

ANALYSIS

C.S.H.B. 491 amends the Code of Criminal Procedure to include among the required registrants for the sex offender registration program a person who has a conviction or adjudication, including an adjudication of delinquent conduct or a deferred adjudication, that, regardless of the pendency of an appeal, is a conviction for, is an adjudication for, or is based on conduct constituting an offense for the continuous trafficking of persons if the offense is based partly or wholly on conduct that constitutes a trafficking of persons offense under certain specified provisions regarding prostitution activities or child trafficking activities; an attempt, conspiracy, or solicitation to engage in such conduct; and a violation of the laws of another state, federal law, the laws of a foreign country, or the Uniform Code of Military Justice for or based on the violation of an offense containing elements that are substantially similar to the elements of such conduct, but not if the violation results in deferred adjudication. The bill includes a continuous trafficking of persons offense based partly or wholly on such conduct among the offenses for which conviction or adjudication, other than an adjudication of delinquent conduct, releases the person from the duty to register for the program when the person dies.

SECTION 3. Articles 62.001 and 62.101, Code of Criminal Procedure, as amended by this Act, apply only to an offense committed on or after the effective date of this Act. An offense committed before the effective date of this Act is governed by the law in effect on the date the offense was committed, and the former law is continued in effect for that purpose. For purposes of this section, an offense was committed before the effective date of this Act if any element of the offense occurred before that date.

SECTION 4. This Act takes effect September 1, 2017.
