A BILL TO BE ENTITLED

1 AN ACT

2 relating to making supplemental appropriations and giving

3 direction and adjustment authority regarding appropriations.

4 BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF TEXAS:

5 SECTION 1. APPROPRIATION REDUCTION: PUBLIC FINANCE

AUTHORITY. The unencumbered appropriations from the general

7 revenue fund to the Public Finance Authority made by Chapter 1281

8 (H.B. 1), Acts of the 84th Legislature, Regular Session, 2015 (the

9 General Appropriations Act), for use during the state fiscal

10 biennium ending August 31, 2017, for bond debt service payments,

11 including appropriations subject to Rider 2, page I-47, Chapter

12 1281 (H.B. 1), Acts of the 84th Legislature, Regular Session, 2015

13 (the General Appropriations Act), to the bill pattern of the

14 appropriations to the authority, are reduced by a total aggregate

15 of \$39,856,983. The Public Finance Authority shall identify the

16 strategies and objectives to which the reduction is to be allocated

17 and the amount of the reduction for each of those strategies and

18 objectives.

19 SECTION 2. HEALTH AND HUMAN SERVICES COMMISSION: MEDICAID

20 SHORTFALL. (a) In addition to amounts previously appropriated for

21 the state fiscal biennium ending August 31, 2017, \$930,733,818 is

22 appropriated from the economic stabilization fund, and

23 \$1,705,243,901 is appropriated from federal funds, to the Health

24 and Human Services Commission for the state fiscal year ending

- 1 August 31, 2017, for Medicaid services under Goal B, Medicaid, as
- 2 listed in Chapter 1281 (H.B. 1), Acts of the 84th Legislature,
- 3 Regular Session, 2015 (the General Appropriations Act).
- 4 (b) The expenditure or emergency transfer of money
- 5 appropriated under Subsection (a) of this section is subject to the
- 6 prior written approval of the Legislative Budget Board in
- 7 accordance with Section 69, Article XVI, Texas Constitution.
- 8 SECTION 3. HEALTH AND HUMAN SERVICES COMMISSION: MEDICAID
- 9 ACUTE CARE THERAPY SERVICES. In addition to amounts previously
- 10 appropriated for the state fiscal biennium ending August 31, 2017,
- 11 \$21,500,000 is appropriated from the economic stabilization fund,
- 12 and \$29,800,000 is appropriated from federal funds, to the Health
- 13 and Human Services Commission for the state fiscal year ending
- 14 August 31, 2017, for Medicaid acute care therapy services, to be
- 15 allocated among provider types and procedure codes for those
- 16 services to preserve access to care.
- 17 SECTION 4. HEALTH AND HUMAN SERVICES COMMISSION: CERTAIN
- 18 RIDERS. Subsection (c), Rider 50, page II-97, Chapter 1281 (H.B.
- 19 1), Acts of the 84th Legislature, Regular Session, 2015 (the
- 20 General Appropriations Act), to the bill pattern of the
- 21 appropriations to the Health and Human Services Commission is
- 22 amended to read as follows:
- c. HHSC shall reform reimbursement methodology to be in line
- 24 with industry standards, policies, and utilization for acute care
- 25 therapy services (including physical, occupational, and speech
- 26 therapies) while considering stakeholder input and access to care.
- 27 In state fiscal year 2017, \$28,500,000 [Out of the amount in

- subsection (a), in each fiscal year at least \$50,000,000] in 1 General Revenue Funds savings should be achieved through rate 2 3 reductions and \$25,000,000 in General Revenue Funds savings may be achieved through various medical policy initiatives listed in items 4 5 (1)-(10), below. [If \$25,000,000 in savings is not achieved through various medical policy initiatives in fiscal year 2016, the 6 amount of unrealized savings (the difference between \$25,000,000 in 7 8 General Revenue Funds and savings actually achieved in fiscal year 2016) should be achieved through additional rate reductions in 9 10 fiscal year 2017 while continuing any initiatives implemented in fiscal year 2016 that have been found to produce savings.] HHSC may 11 12 achieve savings through various medical policy initiatives, taking 13 into consideration the following:
- (1) Clarifying policy language regarding co-therapy
 definition, documentation, and billing requirements,
- (2) Clarifying who can participate in therapy sessions 16 17 in policy that interns, aides, students, orderlies and technicians can participate in therapy sessions when they are directly and 18 19 appropriately supervised according to provider requirements, but they are not eligible to enroll as providers and 20 bill Texas Medicaid for services, 21
- 22 (3) Consolidate Traditional, Comprehensive Care 23 Program and Home Health Agency therapy policies into one policy,
- (4) Require a primary care or treating physician to initiate a signed order or referral prior to an initial therapy evaluation. The initial evaluation may require prior authorization and the signed order or referral must be dated prior to the

- 1 evaluation,
- 2 (5) Require a primary care or treating physician to
- 3 order the therapy services based on the outcomes of the evaluation,
- 4 (6) Clarify medical necessity for therapy services to
- 5 ensure prior authorization staff who are reviewing requests are
- 6 using guidelines based on the nationally recognized standards of
- 7 care,
- 8 (7) Require licensed Medicaid enrolled therapists to
- 9 document and support decisions for continued therapy based on
- 10 professional assessment of a client's progress relative to their
- 11 individual treatment plan and in concert with the client's primary
- 12 care physician and the individual and/or family,
- 13 (8) Ensure appropriate duration of services by
- 14 aligning authorization periods with national standards,
- 15 (9) Streamline prior authorization processes, and
- 16 (10) Implement policies that ensure services are
- 17 provided in the most cost-efficient and medically appropriate
- 18 setting, and implementation of other medical or billing policy
- 19 changes.
- 20 SECTION 5. HEALTH AND HUMAN SERVICES COMMISSION: CRITICAL
- 21 LIFE AND SAFETY NEEDS. In addition to amounts previously
- 22 appropriated for the state fiscal biennium ending August 31, 2017,
- \$188,609,263 is appropriated from the economic stabilization fund
- 24 to the Health and Human Services Commission for the two-year period
- 25 beginning on the effective date of this Act for critical life and
- 26 safety needs at state hospitals and state supported living centers.
- 27 SECTION 6. HEALTH AND HUMAN SERVICES COMMISSION: FORENSIC

- 1 BED CAPACITY. In addition to amounts previously appropriated for
- 2 the state fiscal biennium ending August 31, 2017, \$50,000,000 is
- 3 appropriated from the economic stabilization fund to the Health and
- 4 Human Services Commission for the two-year period beginning on the
- 5 effective date of this Act to increase bed capacity at state
- 6 hospitals and in mental health community hospitals.
- 7 SECTION 7. DEPARTMENT OF FAMILY AND PROTECTIVE SERVICES:
- 8 ADDITIONAL APPROPRIATIONS. In addition to amounts previously
- 9 appropriated for the state fiscal biennium ending August 31, 2017,
- 10 the following amounts are appropriated from the economic
- 11 stabilization fund to the Department of Family and Protective
- 12 Services for the state fiscal year ending August 31, 2017, for the
- 13 following purposes as listed in Chapter 1281 (H.B. 1), Acts of the
- 14 84th Legislature, Regular Session, 2015 (the General
- 15 Appropriations Act):
- 16 (1) \$12,740,200 for Strategy B.1.3., TWC Contracted
- 17 Day Care;
- 18 (2) \$31,993,283 for Strategy B.1.9., Foster Care
- 19 Payments; and
- 20 (3) \$1,576,783 for Strategy B.1.10., Adoption/PCA
- 21 Payments.
- 22 SECTION 8. DEPARTMENT OF FAMILY AND PROTECTIVE SERVICES:
- 23 CERTAIN TRANSFERS. Notwithstanding the limitations of Rider 32,
- 24 page II-43, Chapter 1281 (H.B. 1), Acts of the 84th Legislature,
- 25 Regular Session, 2015 (the General Appropriations Act), to the bill
- 26 pattern of the appropriations to the Department of Family and
- 27 Protective Services, the department shall transfer \$435,475 from

- 1 Strategy B.1.11., Relative Caregiver Payments, to Strategy B.1.9.,
- 2 Foster Care Payments, as listed in Chapter 1281 (H.B. 1), Acts of
- 3 the 84th Legislature, Regular Session, 2015 (the General

- 5 SECTION 9. DEPARTMENT OF FAMILY AND PROTECTIVE SERVICES:
- 6 ADDITIONAL APPROPRIATIONS FOR AGENCY CRITICAL NEEDS. In addition
- 7 to amounts previously appropriated for the state fiscal biennium
- 8 ending August 31, 2017, the Department of Family and Protective
- 9 Services is appropriated for the state fiscal year ending August
- 10 31, 2017, the following amounts from the economic stabilization
- 11 fund for the following strategies as listed in Chapter 1281 (H.B.
- 12 1), Acts of the 84th Legislature, Regular Session, 2015 (the
- 13 General Appropriations Act), to address critical needs of the
- 14 agency with respect to those strategies:
- 15 (1) \$75,521,204 for Strategy B.1.1., CPS Direct
- 16 Delivery Staff;
- 17 (2) \$613,174 for Strategy B.1.2., CPS Program Support;
- 18 (3) \$21,000,000 for Strategy B.1.9., Foster Care
- 19 Payments;
- 20 (4) \$138,854 for Strategy D.1.1., APS Direct Delivery
- 21 Staff;
- 22 (5) \$6,703 for Strategy D.1.2., APS Program Support;
- 23 (6) \$376,259 for Strategy F.1.1., Central
- 24 Administration;
- 25 (7) \$33,546 for Strategy F.1.2., Other Support
- 26 Services;
- 27 (8) \$3,067,626 for Strategy F.1.4., IT Program

- 1 Support; and
- 2 (9) \$940,108 for Strategy G.1.1., Agency-Wide
- 3 Automated Systems.
- 4 SECTION 10. DEPARTMENT OF FAMILY AND PROTECTIVE SERVICES:
- 5 CERTAIN TRANSFERS. (a) Notwithstanding any transfer limitation
- 6 specified in Chapter 1281 (H.B. 1), Acts of the 84th Legislature,
- 7 Regular Session, 2015 (the General Appropriations Act), the
- 8 Department of Family and Protective Services shall transfer to the
- 9 Health and Human Services Commission the following amounts:
- 10 (1) \$29,247,213 of general revenue funds; and
- 11 (2) \$72,450,261 of Temporary Assistance for Needy
- 12 Families (TANF) program federal funds.
- 13 (b) The Health and Human Services Commission may spend
- 14 Temporary Assistance for Needy Families (TANF) program federal
- 15 funds transferred under Subsection (a)(2) of this section during
- 16 the state fiscal year ending August 31, 2017, only with the prior
- 17 written approval of the Legislative Budget Board in accordance with
- 18 Section 69, Article XVI, Texas Constitution.
- 19 SECTION 11. DEPARTMENT OF CRIMINAL JUSTICE: CORRECTIONAL
- 20 MANAGED HEALTH CARE SHORTFALL. In addition to amounts previously
- 21 appropriated for the state fiscal biennium ending August 31, 2017,
- 22 \$80,000,000 is appropriated from the economic stabilization fund to
- 23 the Department of Criminal Justice for the state fiscal year ending
- 24 August 31, 2017, for correctional managed health care under
- 25 Strategy C.1.9., Hospital and Clinical Care, as listed in Chapter
- 26 1281 (H.B. 1), Acts of the 84th Legislature, Regular Session, 2015
- 27 (the General Appropriations Act).

- 1 SECTION 12. TEXAS A&M FOREST SERVICE: APPROPRIATION FOR
- 2 GENERAL COSTS CAUSED BY VARIOUS EMERGENCY WEATHER-RELATED
- 3 RESPONSES. In addition to amounts previously appropriated for the
- 4 state fiscal biennium ending August 31, 2017, \$5,100,000 is
- 5 appropriated from the economic stabilization fund to the Texas A&M
- 6 Forest Service for the state fiscal year ending August 31, 2017, for
- 7 the purpose of paying for, or reimbursing payments made for, costs
- 8 incurred by the forest service associated with responding to
- 9 various weather-related emergencies.
- 10 SECTION 13. ANIMAL HEALTH COMMISSION: CATTLE FEVER TICKS.
- 11 (a) In addition to amounts previously appropriated for the state
- 12 fiscal biennium ending August 31, 2017, \$649,987 is appropriated
- 13 from the economic stabilization fund to the Animal Health
- 14 Commission for the state fiscal year ending August 31, 2017, for
- 15 preparedness for, response to, and mitigation of cattle fever ticks
- 16 under Strategy A.1.1., Field Operations, as listed in Chapter 1281
- 17 (H.B. 1), Acts of the 84th Legislature, Regular Session, 2015 (the
- 18 General Appropriations Act).
- 19 (b) The amount of \$7,169,791 is appropriated from the
- 20 economic stabilization fund to the Animal Health Commission for the
- 21 state fiscal biennium beginning September 1, 2017, for preparedness
- 22 for, response to, and mitigation of cattle fever ticks.
- 23 SECTION 14. EFFECTIVE DATE. (a) Except as provided by
- 24 Subsection (b) of this section, this Act takes effect immediately.
- 25 (b) Sections 2, 3, 5, 6, 7, 9, 11, 12, and 13 of this Act take
- 26 effect only if this Act receives a vote of two-thirds of the members
- 27 present in each house of the legislature, as provided by Section
