A BILL TO BE ENTITLED 1 AN ACT 2 relating to the prosecution of the offense of improper relationship 3 between educator and student. BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF TEXAS: 4 5 SECTION 1. Section 21.12(a), Penal Code, is amended to read as follows: 6 7 (a) An employee of a public or private primary or secondary 8 school commits an offense if the employee: 9 (1) engages in sexual contact, sexual intercourse, or deviate sexual intercourse with a person who is enrolled in a public 10 or private primary or secondary school at which the employee works; 11 12 (2) holds a certificate or permit issued as provided by Subchapter B, Chapter 21, Education Code, or is a person who is 13 required to be licensed by a state agency as provided by Section 14 21.003(b), Education Code, and engages in sexual contact, sexual 15 16 intercourse, or deviate sexual intercourse with a person the employee knows is: 17 18 enrolled in a public or private primary or (A) secondary school in this state, other than a school described by 19 Subdivision (1) [the same school district as the school at which the 20 21 employee works]; or 22 a student participant in an educational (B) 23 activity that is sponsored by a school district or a public or private primary or secondary school, if[+ 24

1 [(:)] students enrolled in a public or 2 private primary or secondary school are the primary participants in 3 the activity; [and

4 [(ii) the employee provides education 5 services to those participants;] or

(3) engages in conduct described by Section 33.021,
with a person described by Subdivision (1), or a person the employee
knows is a person described by Subdivision (2)(A) or (B),
regardless of the age of that person.

SECTION 2. The change in law made by this Act applies only 10 to an offense committed on or after the effective date of this Act. 11 An offense committed before the effective date of this Act is 12 governed by the law in effect on the date the offense was committed, 13 and the former law is continued in effect for that purpose. For 14 15 purposes of this section, an offense was committed before the effective date of this Act if any element of the offense was 16 committed before that date. 17

SECTION 3. This Act takes effect September 1, 2017.
