- Sec. 2270.002. PROVISION REQUIRED IN 16
- governmental entity may not enter into a contract with a company for 17

3	SUBCHAPTER A. GENERAL PROVISIONS
4	Sec. 808.001. DEFINITIONS. In this chapter:
5	(1) "Boycott Israel" means refusing to deal with,
6	terminating business activities with, or otherwise taking any
7	action that is intended to penalize, inflict economic harm on, or
8	limit commercial relations specifically with Israel, or with a
9	person or entity doing business in Israel or in an
10	Israeli-controlled territory, but does not include an action made
11	for ordinary business purposes.
12	(2) "Company" means a for-profit sole proprietorship,
13	organization, association, corporation, partnership, joint
14	venture, limited partnership, limited liability partnership, or
15	limited liability company, including a wholly owned subsidiary,
16	majority-owned subsidiary, parent company, or affiliate of those
17	entities or business associations that exists to make a profit.
18	(3) "Direct holdings" means, with respect to a
19	company, all securities of that company held directly by a state
20	governmental entity in an account or fund in which a state
21	governmental entity owns all shares or interests.
22	(4) "Indirect holdings" means, with respect to a
23	company, all securities of that company held in an account or fund,
24	such as a mutual fund, managed by one or more persons not employed

- 22 <u>SUBCHAPTER B. DUTIES REGARDING INVESTMENTS</u>
- Sec. 808.051. LISTED COMPANIES. (a) The comptroller shall
- 24 prepare and maintain, and provide to each state governmental
- 25 entity, a list of all companies that boycott Israel. In maintaining
- 26 the list, the comptroller may review and rely, as appropriate in the
- 27 comptroller's judgment, on publicly available information

- 1 regarding companies, including information provided by the state,

- 19 Sec. 808.053. ACTIONS RELATING TO LISTED COMPANY. (a) For

- Sec. 808.054. DIVESTMENT OF ASSETS. (a) A state
- 17 governmental entity required to sell, redeem, divest, or withdraw
- 18 all publicly traded securities of a listed company shall comply
- 19 with the following schedule:
- 20 (1) at least 50 percent of those assets must be removed
- 21 from the state governmental entity's assets under management not
- 22 later than the 180th day after the date the company receives notice
- 23 <u>under Section 808.053</u> or <u>Subsection</u> (b) <u>unless the state</u>
- 24 governmental entity determines, based on a good faith exercise of
- 25 its fiduciary discretion and subject to Subdivision (2), that a

- 9 company according to the schedule in Subsection (a).
- 10 (c) Except as provided by Subsection (a), a state
- 11 governmental entity may delay the schedule for divestment under
- 12 that subsection only to the extent that the state governmental
- 13 entity determines, in the state governmental entity's good faith
- 14 judgment, and consistent with the entity's fiduciary duty, that
- 15 divestment from listed companies will likely result in a loss in
- 16 value or a benchmark deviation described by Section 808.056(a). If
- 17 a state governmental entity delays the schedule for divestment, the
- 18 state governmental entity shall submit a report to the presiding
- 19 officer of each house of the legislature and the attorney general
- 20 stating the reasons and justification for the state governmental
- 21 entity's delay in divestment from listed companies. The report
- 22 <u>must include documentation supporting its determination that the</u>
- 23 <u>divestment would result in a loss in value or a benchmark deviation</u>

- 25 estimates. The state governmental entity shall update the report

- Sec. 808.055. INVESTMENTS EXEMPTED FROM DIVESTMENT. A

- 1 state governmental entity is not required to divest from any
- 2 indirect holdings in actively or passively managed investment funds
- 3 or private equity funds. The state governmental entity shall
- 4 submit letters to the managers of each investment fund containing
- 5 listed companies requesting that they remove those companies from
- 6 the fund or create a similar actively or passively managed fund with
- 7 indirect holdings devoid of listed companies. If a manager creates
- 8 a similar fund with substantially the same management fees and same
- 9 level of investment risk and anticipated return, the state
- 10 governmental entity may replace all applicable investments with

- 14 Sec. 808.056. AUTHORIZED INVESTMENT IN LISTED COMPANIES.
- 15 (a) A state governmental entity may cease divesting from one or
- 16 more listed companies only if clear and convincing evidence shows
- 17 that:
- 18 (1) the state governmental entity has suffered or will
- 19 suffer a loss in the hypothetical value of all assets under
- 20 management by the state governmental entity as a result of having to
- 21 divest from listed companies under this chapter; or
- 22 (2) an individual portfolio that uses a

- 16 by Section 808.056, a state governmental entity may not acquire

- SUBCHAPTER C. REPORT; ENFORCEMENT
- 19 Sec. 808.101. REPORT. Not later than January 5 of each
- 20 year, each state governmental entity shall file a publicly
- 21 available report with the presiding officer of each house of the

- 23 <u>(1) identifies all securities sold, redeemed,</u>
- 24 divested, or withdrawn in compliance with Section 808.054;
