8	amended to read as follows:

11	[(A) disabled or at least 65 years of age; and
12	[ <del>(B)</del> ] qualified for an exemption under Section
13	<u>11.13,</u> [ <del>11.13(c); or</del>

15	[ <del>(A) a disabled veteran or the unmarried</del>
16	surviving spouse of a disabled veteran; and
17	[ <del>(B) qualified for an exemption under Section</del> ]

19	SECTION 2. This Act applies only to ad valorem taxes imposed
20	for a tax year beginning on or after the effective date of this Act.
21	SECTION 3. This Act takes effect January 1, 2018.
