No. 239 1 caloric intake of a pregnant inmate and other dietary information; 2 (B) work assignments; 3 (C) housing conditions; and 4 (D) situations in which a pregnant inmate has 5 been restrained, including the reason a determination to use restraints was made under Section 501.066, Government Code; and 6 the number of miscarriages experienced by pregnant 7 (4) 8 inmates while confined in a facility operated by or under contract with the department between September 1, 2017, and September 1, 9 2018. 10 Not later than December 1, 2018, the department shall 11 (c) 12 provide a copy of the report to: (1) the governor; 13 14 (2) the lieutenant governor; 15 (3) the speaker of the house of representatives; and 16 (4) each standing committee of the senate and house of 17 representatives having primary jurisdiction over matters relating to corrections. 18 SECTION 2. This Act expires February 1, 2019. 19 SECTION 3. This Act takes effect September 1, 2017. 20
