Subchapter G, Chapter 814, Government Code, is amended by adding Sections 814.605 and 814.606 to read as follows: 6 Sec. 814.605. ADJUSTMENT TO BENEFITS. (a) The amount of a 7 monthly service retirement benefit, disability retirement benefit, 8 9 or death benefit paid under this chapter to a retiree or beneficiary for service credited in the employee class is increased to include a 10 11 10 percent adjustment in accordance with this section. 12 (b) The board of trustees shall recompute the amount of a benefit paid monthly under this chapter by applying the 10 percent 13 14 adjustment to the monthly amount otherwise required to be paid as determined in accordance with this chapter. 15 Sec. 814.606. ANNUAL COST-OF-LIVING ADJUSTMENT. (a) 16 The amount of a monthly service retirement benefit, disability 17 retirement benefit, or death benefit paid under this chapter to a 18 retiree or beneficiary for service credited in the employee class 19 is increased to include a four percent annual cost-of-living 20 21 adjustment in accordance with this section. 22 (b) The board of trustees shall recompute the amount of a 23 benefit paid monthly under this chapter by applying the four percent adjustment to the monthly amount otherwise required to be 24

1 paid as determined in accordance with this chapter.

2 SECTION 2. (a) The Employees Retirement System of Texas 3 shall make a one-time supplemental payment of a retirement or death 4 benefit, as provided by this section.

5 (b) A supplemental payment is payable in January 2018, and, 6 to the extent practicable, on a date or dates that coincide with the 7 regular annuity payment payable to each eligible annuitant.

8 (c) The amount of the supplemental payment is equal to the 9 lesser of:

10

(1) \$2,000; or

11 (2) the gross amount of the regular annuity payment to 12 which the eligible annuitant is otherwise entitled for the month of 13 December 2017.

(d) The Employees Retirement System of Texas shall make applicable tax withholding and other legally required deductions before disbursing the supplemental payment. A supplemental payment under this section is in addition to and not in lieu of the regular monthly annuity payment to which the eligible annuitant is otherwise entitled.

(e) Subject to Subsections (f) and (g) of this section, to
21 be eligible for the supplemental payment, a person must be, for the
22 month of December 2017, an annuitant eligible to receive:

(1) a standard retirement annuity payment;

(2) an optional service retirement annuity payment as
either a retiree or beneficiary under Section 814.108, Government
Code;

2 (4) a death benefit annuity payment under Section
3 814.305, Government Code; or

4 (5) an alternate payee annuity payment under Section
5 804.005, Government Code.

(f) If the annuitant is a retiree or a beneficiary under an 6 7 optional retirement payment plan, to be eligible for the 8 supplemental payment, the effective date of the retirement of the member of the Employees Retirement System of Texas must have been on 9 10 or before September 1, 2016. The supplemental payment shall be made to an alternate payee who is an annuitant under Section 804.005, 11 12 Government Code, only if the annuity payment to the alternate payee commenced on or before September 1, 2016. The supplemental payment 13 14 is in addition to the guaranteed number of payments under Section 814.108, Government Code, and may not be counted as one of the 15 16 guaranteed monthly payments.

17 (g) The supplemental payment does not apply to payments 18 under:

(1) Section 814.103 or 814.205, Government Code, relating to retirees or disability retirees from the elected class of membership;

(2) a subtitle other than Subtitle B, Title 8,
Government Code, except as provided by Subsection (e)(5) of this
section; or

(3) Section 814.304, Government Code, relating to
retiree survivor beneficiaries who receive a survivor annuity as
the surviving spouse of a member of the elected class.

1 (h) Except as provided by this section, the board of 2 trustees of the Employees Retirement System of Texas shall 3 determine the eligibility for and the amount and timing of a 4 supplemental payment and the manner in which the payment is made.

5 (i) The supplemental payment is subject solely to the 6 availability of appropriated funds. The supplemental payment must 7 comply with Section 811.006, Government Code.

8 SECTION 3. Section 814.604, Government Code, is repealed.

9 SECTION 4. Sections 814.605 and 814.606, Government Code, 10 as added by this Act, apply only to a monthly benefit payment made 11 by the Employees Retirement System of Texas on or after September 1, 12 2017.

SECTION 5. This Act takes effect September 1, 2017.
