Subtitle A, Title 6, Government Code, is amended 7 by adding Chapter 620 to read as follows: CHAPTER 620. PROHIBITION ON STATE TRAVEL TO STATES WITH CERTAIN 8 9 DISCRIMINATORY LAWS Sec. 620.001. DEFINITIONS. In this chapter: 10 11 (1) "Gender identity or expression" means having or 12 being perceived as having gender-related identity, appearance, expression, or behavior, regardless of whether that identity, 13 14 appearance, expression, or behavior is different from that commonly associated with the individual's actual or perceived sex. 15 16 (2) "Sexual orientation" means the actual or perceived status of an individual with respect to the individual's sexuality. 17 18 (3) "State agency" means a board, commission, department, office, or other agency in the executive or legislative 19 branch of state government. The term includes an institution of 20 21 higher education, the senate, and the house of representatives. 22 (4) "State employee" means a person who receives 23 compensation for service performed, other than as an independent contractor, for a state agency. The term includes a state officer or 24

2	Sec. 620.002. APPLICABILITY. (a) Except as provided by
3	Subsection (b), this chapter applies only to travel to a state other
4	than this state that, after June 26, 2015, enacted a law that:
5	(1) voids or repeals any existing protection against
6	discrimination on the basis of sexual orientation or gender
7	identity or expression;
8	(2) authorizes or requires discrimination against
9	same-sex couples or their families or on the basis of sexual
10	orientation or gender identity or expression; or
11	(3) creates an exemption to an antidiscrimination law
12	in order to permit discrimination against same-sex couples or their
13	families or on the basis of sexual orientation or gender identity or
14	expression.
15	(b) This chapter does not apply to travel to a state
16	described by Subsection (a) after the date all laws described by
17	Subsections (a)(1)-(3) are repealed or otherwise become
18	ineffective in that state.
19	Sec. 620.003. CERTAIN STATE TRAVEL PROHIBITED. A state
20	agency may not:
21	(1) require a state employee to travel to a state
22	described by Section 620.002(a); or
23	(2) except as provided by Section 620.004, approve a
24	request for state-funded or state-sponsored travel to a state
25	described by Section 620.002(a).
26	Sec. 620.004. EXCEPTIONS. Section 620.003(2) does not
27	apply to travel that is required for:

1	(1) enforcement of this state's law, including
2	auditing or revenue collection;
3	(2) litigation;
4	(3) compliance with a contractual obligation incurred
5	before September 1, 2017;
6	(4) compliance with a federal government request to
7	appear before a committee;
8	(5) participation in training or a meeting, if
9	participation is required by a grant or required to maintain grant
10	funding;
11	(6) completion of job training necessary to maintain a
12	license or a similar requirement to hold a position, if the training
13	is not available in this state or a state to which Section
14	620.002(a) does not apply; or
15	(7) the protection of public health, welfare, or
16	safety as determined by the state agency.
17	SECTION 2. This Act takes effect September 1, 2017.
