5	BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF TEXAS:
6	SECTION 1. Section 39.023(a), Education Code, as effective
7	September 1, 2017, is amended to read as follows:
8	(a) The agency shall adopt or develop appropriate
9	criterion-referenced assessment instruments designed to assess
10	essential knowledge and skills in subjects for which assessment is
11	required by federal law [reading, writing, mathematics, social
12	studies, and science]. Except as provided by Subsection (a-2), all
13	students, other than students assessed under Subsection (b) or (1)
14	or exempted under Section 39.027, shall be assessed in [\div
15	[(1) mathematics, annually in grades three through
16	seven without the aid of technology and in grade eight with the aid
17	of technology on any assessment instrument that includes algebra;
18	[(2) reading, annually in grades three through eight;
19	[(3) writing, including spelling and grammar, ir
20	grades four and seven;
21	[(4) social studies, in grade eight;
22	[(5) science, in grades five and eight; and
23	$[rac{(6)}{}]$ any $[rac{ ext{other}}{}]$ subject and grade required by
24	federal law.

- 1 SECTION 2. Sections 39.02301(a) and (d), Education Code,
- 2 are amended to read as follows:
- 3 (a) During the 2015-2016 school year, the agency, in
- 4 coordination with the entity that has been contracted to develop or
- 5 implement assessment instruments under Section 39.023, shall
- 6 conduct a study to develop a writing assessment method as an
- 7 alternative to the writing assessment instruments required under
- 8 Section 39.023(c) [Sections 39.023(a) and (c)]. The writing
- 9 assessment method must be designed to assess:
- 10 (1) a student's mastery of the essential knowledge and
- 11 skills in writing through timed writing samples;
- 12 (2) improvement of a student's writing skills from the
- 13 beginning of the school year to the end of the school year;
- 14 (3) a student's ability to follow the writing process
- 15 from rough draft to final product; and
- 16 (4) a student's ability to produce more than one type
- 17 of writing style.
- 18 (d) A school district designated to participate in the pilot
- 19 program under this section is not required to comply with the
- 20 writing assessment requirements under <u>Section 39.023(c)</u> [<u>Sections</u>
- 21 $\frac{39.023(a)}{and}$ and (c) during the period the district is participating
- 22 in the pilot program. The agency shall, to the greatest extent
- 23 practicable, apply cost savings that result from the exemption
- 24 under this subsection to offset the costs accrued under this
- 25 section.
- SECTION 3. This Act takes effect September 1, 2017.
