## A BILL TO BE ENTITLED

1 AN ACT

2 relating to the preference given by state agencies to goods offered

- 3 by bidders in this state or manufactured, produced, or grown in this
- 4 state or in the United States.
- 5 BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF TEXAS:
- 6 SECTION 1. Sections 2155.444(a), (b), and (c), Government
- 7 Code, are amended to read as follows:
- 8 (a) The <u>comptroller</u> [<del>commission</del>] and all state agencies
- 9 making purchases of goods, including agricultural products, shall
- 10 promote the purchase of and give preference to goods manufactured,
- 11 [ $\frac{\text{those}}{\text{or}}$ ] produced or grown in this state or offered by Texas bidders
- 12 as follows:
- 13 (1) goods <u>manufactured</u>, produced, or offered by a
- 14 Texas bidder that is owned by a service-disabled veteran who is a
- 15 Texas resident shall be given a first preference and goods
- 16 manufactured or produced in this state or offered by other Texas
- 17 bidders shall be given second preference, if the cost to the state
- 18 and quality are equal; and
- 19 (2) agricultural products grown in this state shall be
- 20 given first preference and agricultural products offered by Texas
- 21 bidders shall be given second preference, if the cost to the state
- 22 and quality are equal.
- 23 (b) If goods, including agricultural products,
- 24 manufactured, produced, or grown in this state or offered by Texas

- 1 bidders are not equal in cost and quality to other products, then
- 2 goods, including agricultural products, <u>manufactured</u>, produced, or
- 3 grown in other states of the United States shall be given preference
- 4 over foreign products if the cost to the state and quality are
- 5 equal.
- 6 (c) In this section:
- 7 (1) "Agricultural products" includes textiles and
- 8 other similar products.
- 9 (2) "Manufactured" means, with respect to a
- 10 manufactured good, an item produced as a result of a manufacturing
- 11 process that alters the form or function of components, including
- 12 <u>articles</u>, materials, or supplies, that are directly incorporated
- 13 <u>into the item in a manner that adds value and transforms the</u>
- 14 components, and that is functionally distinct from a finished item
- 15 produced merely from assembling the components into the item.
- 16  $\underline{\text{(3)}}$  [\frac{\tangle (1-a)}{\tangle}] "Service-disabled veteran" means a
- 17 person who is a veteran as defined by 38 U.S.C. Section 101(2) and
- 18 who has a service-connected disability as defined by 38 U.S.C.
- 19 Section 101(16).
- 20 (4)  $\left[\frac{(2)}{2}\right]$  "Texas bidder" means a business:
- 21 (A) incorporated in this state;
- 22 (B) that has its principal place of business in
- 23 this state; or
- (C) that has an established physical presence in
- 25 this state.
- 26 SECTION 2. The change in law made by this Act applies only
- 27 to a contract for goods that is entered into on or after the

- 1 effective date of this Act. A contract entered into before the
- 2 effective date of this Act is governed by the law in effect on the
- 3 date the contract was entered into, and the former law is continued
- 4 in effect for that purpose.
- 5 SECTION 3. This Act takes effect September 1, 2017.
