H.B. No. 774

A BILL TO BE ENTITLED

1 AN ACT

2 relating to the issuance of a citation or notice to appear for

- 3 certain misdemeanors punishable by a fine only.
- 4 BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF TEXAS:
- 5 SECTION 1. Article 14.06, Code of Criminal Procedure, is
- 6 amended by amending Subsection (b) and adding Subsection (b-1) to
- 7 read as follows:
- 8 (b) A peace officer who is charging a person, including a
- 9 child, with committing an offense that is a [Class C] misdemeanor
- 10 punishable by a fine only, other than an offense under Section
- 11 49.02, Penal Code, or an offense under Chapter 106, Alcoholic
- 12 Beverage Code, shall [may], instead of taking the person before a
- 13 magistrate, issue a citation to the person that contains written
- 14 notice of the time and place the person must appear before a
- 15 magistrate, the name and address of the person charged, the offense
- 16 charged, and the following admonishment, in boldfaced or underlined
- 17 type or in capital letters:
- "If you are convicted of a misdemeanor offense involving
- 19 violence where you are or were a spouse, intimate partner, parent,
- 20 or guardian of the victim or are or were involved in another,
- 21 similar relationship with the victim, it may be unlawful for you to
- 22 possess or purchase a firearm, including a handgun or long gun, or
- 23 ammunition, pursuant to federal law under 18 U.S.C. Section
- 24 922(g)(9) or Section 46.04(b), Texas Penal Code. If you have any

- 1 questions whether these laws make it illegal for you to possess or
- 2 purchase a firearm, you should consult an attorney."
- 3 (b-1) A peace officer who is charging a person, including a
- 4 child, with committing an offense that is a misdemeanor punishable
- 5 by a fine only under Chapter 106, Alcoholic Beverage Code, may,
- 6 instead of taking the person before a magistrate, issue to the
- 7 person a citation that contains written notice of the time and place
- 8 the person must appear before a magistrate, the name and address of
- 9 the person charged, and the offense charged.
- 10 SECTION 2. Section 543.004(a), Transportation Code, is
- 11 amended to read as follows:
- 12 (a) An officer shall issue a written notice to appear if:
- 13 (1) the offense charged is [speeding or] a misdemeanor
- 14 under this subtitle that is punishable by a fine only [violation of
- 15 the open container law, Section 49.03, Penal Code]; and
- 16 (2) the person makes a written promise to appear in
- 17 court as provided by Section 543.005.
- SECTION 3. Subchapter A, Chapter 543, Transportation Code,
- 19 is amended by adding Section 543.0045 to read as follows:
- Sec. 543.0045. NOTIFICATION REQUIRED DURING TRAFFIC STOP.
- 21 (a) An officer who stops a motor vehicle as a result of a person's
- 22 alleged commission of a misdemeanor under this subtitle that is
- 23 punishable by a fine only shall promptly notify the person that:
- 24 (1) the alleged offense is a misdemeanor under this
- 25 subtitle that is punishable by a fine only; and
- 26 (2) the officer may not arrest a person solely on the
- 27 basis of that offense.

- 1 (b) The Texas Commission on Law Enforcement by rule shall
- 2 specify the language that is required to be included in the
- 3 notification <u>described</u> by <u>Subsection (a).</u>
- 4 SECTION 4. The changes in law made by this Act apply only to
- 5 an offense committed on or after the effective date of this Act. An
- 6 offense committed before the effective date of this Act is governed
- 7 by the law in effect on the date the offense was committed, and the
- 8 former law is continued in effect for that purpose. For purposes of
- 9 this section, an offense was committed before the effective date of
- 10 this Act if any element of the offense occurred before that date.
- 11 SECTION 5. The Texas Commission on Law Enforcement shall
- 12 adopt the rules required by Section 543.0045(b), Transportation
- 13 Code, as added by this Act, not later than December 1, 2017.
- 14 SECTION 6. (a) Except as provided by Subsection (b) of this
- 15 section, this Act takes effect September 1, 2017.
- 16 (b) Section 543.0045, Transportation Code, as added by this
- 17 Act, takes effect January 1, 2018.
