## A BILL TO BE ENTITLED

1	AN ACT
2	relating to honesty in state taxation.
3	BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF TEXAS:
4	SECTION 1. Subtitle A, Title 2, Tax Code, is amended by
5	adding Chapter 102 to read as follows:
6	CHAPTER 102. HONESTY IN STATE TAXATION
7	Sec. 102.001. LEGISLATIVE FINDINGS AND INTENT. The
8	legislature finds that this state has hidden from taxpayers the
9	enactment and increase of state taxes by describing the taxes by
10	other names such as "fees," "surcharges," "assessments," and
11	"penalties." It is the intent of the legislature to establish
12	honesty in state taxation and to appropriately identify state
13	taxes.
14	Sec. 102.002. DEFINITIONS. In this chapter:
15	(1) "Regulatory tax" means a fee, levy, surcharge,
16	assessment, penalty, or other charge of any kind imposed by this
17	state for a primary purpose other than to raise revenue for general
18	<pre>purposes, including:</pre>
19	(A) a charge imposed for a specific benefit
20	conferred or privilege granted directly to the taxpayer that is not
21	provided to a person who did not pay the charge and that does not
22	exceed the reasonable cost to this state of conferring the benefit
23	or granting the privilege;
24	(B) a charge imposed for a specific state service

- 1 or product provided directly to the taxpayer that is not provided to
- 2 a person who did not pay the charge and that does not exceed the
- 3 reasonable cost to this state of providing the service or product;
- 4 (C) a charge imposed for the reasonable
- 5 regulatory cost to this state related to the issuance of a license
- 6 or permit, the performance of an investigation, inspection, or
- 7 audit, or the enforcement of a state law or order;
- 8 (D) a charge imposed for the purchase, rental,
- 9 lease, or other use of state property; and
- 10 (E) a fine, penalty, or other monetary charge
- 11 imposed by this state for or in connection with a violation of a
- 12 state law or order.
- 13 (2) "State agency" means:
- 14 (A) a board, commission, department, or other
- 15 agency in the executive branch of state government that is created
- 16 by the constitution or a statute of this state, including an
- 17 institution of higher education as defined by Section 61.003,
- 18 Education Code, other than a public junior college, as defined by
- 19 that section;
- 20 (B) the legislature or a legislative agency; or
- (C) the supreme court, the court of criminal
- 22 appeals, a court of appeals, or a state judicial agency.
- Sec. 102.003. USE OF HONEST STATE TAXATION TERMINOLOGY
- 24 REQUIRED IN LEGISLATION. The legislature and the Texas Legislative
- 25 <u>Council are directed to:</u>
- 26 (1) not identify a state tax, including a regulatory
- 27 tax, as another type of state charge such as a "fee," "surcharge,"

- 1 "assessment," or "penalty" in any new statute or resolution; and
- 2 (2) change a reference to a state charge that is not
- 3 correctly identified as a state tax in the course of otherwise
- 4 amending the state law containing the reference.
- 5 Sec. 102.004. USE OF HONEST STATE TAXATION TERMINOLOGY
- 6 REQUIRED IN STATE RULES, MATERIALS, PUBLICATIONS, AND ELECTRONIC
- 7 MEDIA. A state agency:
- 8 <u>(1) may not identify a state tax, including a</u>
- 9 regulatory tax, as another type of state charge such as a "fee,"
- 10 "surcharge," "assessment," or "penalty" when proposing or adopting
- 11 the agency's rules, reference materials, publications, and
- 12 electronic media; and
- 13 (2) shall change a reference to a state charge that is
- 14 not correctly identified as a state tax when amending the agency's
- 15 rules, reference materials, publications, and electronic media.
- SECTION 2. Chapter 325, Government Code, is amended by
- 17 adding Section 325.0124 to read as follows:
- 18 Sec. 325.0124. REVIEW OF STATE AGENCIES FOR HONEST STATE
- 19 TAXATION TERMINOLOGY. As part of its review of a state agency, the
- 20 commission shall consider and make recommendations regarding
- 21 statutory revisions necessary to correctly identify state charges
- 22 as state taxes in accordance with the legislative intent prescribed
- 23 <u>by Chapter 102, Ta</u>x Code.
- SECTION 3. This Act takes effect September 1, 2017.
