2	relating to the establishment of a state plan for Streptococcus

4	BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF TEXAS:
5	SECTION 1. Subtitle D, Title 2, Health and Safety Code, is
6	amended by adding Chapter 94A to read as follows:
7	CHAPTER 94A. STATE PLAN FOR STREPTOCOCCUS PNEUMONIAE; EDUCATION
8	AND PREVENTION PROGRAM
9	Sec. 94A.001. STATE PLAN FOR STREPTOCOCCUS PNEUMONIAE. (a)
10	The department, using existing resources and programs to the extent
11	possible, shall develop a state plan for prevention and treatment
12	of diseases caused by Streptococcus pneumoniae. The plan must
13	include strategies for prevention and treatment of diseases caused
14	by Streptococcus pneumoniae in specific demographic groups that are
15	disproportionately affected by the diseases, including persons who
16	are elderly, children under two years of age, persons living in
17	long-term care facilities, persons with a chronic heart or lung
18	disease, smokers, and persons with asplenia.
19	(b) In developing the plan, the department shall seek the
20	advice of:
21	(1) the public, including members of the public who
22	have been infected with Streptococcus pneumoniae;
23	(2) each state agency that provides services to
24	persons infected with Streptococcus pneumoniae or that is assigned

- 2 including any appropriate health and human services agency
- 3 <u>described</u> by Section 531.001, Government Code, the Employees
- 4 Retirement System of Texas, and the Teacher Retirement System of
- 5 Texas;
- 6 (3) any advisory body that addresses issues related to
- 7 <u>diseases caused by Streptococcus pneumoniae;</u>
- 8 <u>(4) public advocates concerned with issues related to</u>
- 9 diseases caused by Streptococcus pneumoniae;
- 10 (5) providers of services to persons with diseases
- 11 caused by Streptococcus pneumoniae;
- 12 (6) a statewide professional association of
- 13 physicians; and
- 14 (7) a statewide professional association of nurses.
- 15 <u>(c)</u> The department shall review and modify as necessary the
- 16 state plan developed under this section at least once every five
- 17 years and may update the state plan biennially.
- 18 Sec. 94A.002. STREPTOCOCCUS PNEUMONIAE EDUCATION AND
- 19 PREVENTION PROGRAM. (a) The department shall develop a program to
- 20 heighten awareness and enhance knowledge and understanding of
- 21 Streptococcus pneumoniae.
- 22 <u>(b) The program developed under Subsection (a) must require</u>
- 23 the department to:
- 24 (1) conduct health education, public awareness, and
- 25 community outreach activities to promote public awareness and
- 26 knowledge about the risk factors for, the value of early detection
- 27 of, available screening services for, and the options available for

- 1 the treatment of diseases caused by Streptococcus pneumoniae; and
- 2 (2) post on the department's Internet website the
- 3 options available for the prevention, treatment, and detection of
- 4 diseases caused by Streptococcus pneumoniae and information on the
- 5 risk factors for, method of transmission of, and value of early
- 6 detection of the diseases.
- 7 (c) The department, using existing resources, may include
- 8 <u>in the program developed under Subsection (a) a study to estimate</u>
- 9 the current and future impact on this state of diseases caused by
- 10 Streptococcus pneumoniae.
- 11 SECTION 2. This Act takes effect September 1, 2017.
