Section 31.03(e), Penal Code, is amended to read 7 as follows: (e) Except as provided by Subsection (f), an offense under 8 9 this section is: (1) a Class C misdemeanor if the value of the property 10 stolen is less than \$100; 11 12 (2) a Class B misdemeanor if: 13 (A) the value of the property stolen is \$100 or more but less than \$750; 14 (B) the value of the property stolen is less than 15 16 \$100 and the defendant has previously been convicted of any grade of 17 theft; or 18 (C) the property stolen is a driver's license, commercial driver's license, or 19 personal identification 20 certificate issued by this state or another state; 21 (3) a Class A misdemeanor if the value of the property stolen is \$750 or more but less than \$2,500; 22 23 (4) a state jail felony if: 24 the value of the property stolen is \$2,500 or (A)

more but less than \$30,000, or the property is less than 10 head of 1 sheep, swine, or goats or any part thereof under the value of 2 3 \$30,000; 4 (B) regardless of value, the property is stolen 5 from the person of another or from a human corpse or grave, including property that is a military grave marker; 6 7 (C) the property stolen is a firearm, as defined 8 by Section 46.01; 9 (D) the value of the property stolen is less than \$2,500 and the defendant has been previously convicted two or more 10 times of any grade of theft; 11 the property stolen is an official ballot or 12 (E) official carrier envelope for an election; or 13 14 (F) the value of the property stolen is less than 15 \$20,000 and the property stolen is: (i) aluminum; 16 17 (ii) bronze; 18 (iii) copper; or 19 (iv) brass; a felony of the third degree if the value of the 20 (5) property stolen is \$30,000 or more but less than \$150,000, or the 21 property is: 22 cattle, horses, or exotic livestock or exotic 23 (A) 24 fowl as defined by Section 142.001, Agriculture Code, stolen during a single transaction and having an aggregate value of less than 25 \$150,000; [or] 26 10 or more head of sheep, swine, or goats 27 (B)

stolen during a single transaction and having an aggregate value of
less than \$150,000; or

3 (C) a trailer, semitrailer, farm tractor, or 4 implement of husbandry, as defined by Section 541.201, 5 Transportation Code, that has a value of less than \$30,000;

6 (6) a felony of the second degree if:

7 (A) the value of the property stolen is \$150,0008 or more but less than \$300,000; or

9 (B) the value of the property stolen is less than 10 \$300,000 and the property stolen is an automated teller machine or 11 the contents or components of an automated teller machine; or

12 (7) a felony of the first degree if the value of the13 property stolen is \$300,000 or more.

SECTION 2. The change in law made by this Act applies only 14 15 to an offense committed on or after the effective date of this Act. An offense committed before the effective date of this Act is 16 17 governed by the law in effect on the date the offense was committed, and the former law is continued in effect for that purpose. For 18 purposes of this section, an offense was committed before the 19 effective date of this Act if any element of the offense occurred 20 before that date. 21
