GOVERNOR'S APPROVAL REQUIRED FOR CERTAIN 8 CONVEYANCES OF LAND. (a) A political subdivision must provide the 9 governor with advance notice of a proposed conveyance of land owned 10 by the political subdivision to the United States. The notice must 11 be sent to the governor not later than the 30th day before the date: 12 (1) notice is published under Section 272.001; or 13 14 (2) the land is offered for sale or exchange, if Section 272.001 is not applicable to the sale or exchange. 15 16 (b) In addition to the advance notice of the proposed conveyance to the United States, the political subdivision shall 17 submit to the governor a formal request for approval of the sale or 18 exchange. The political subdivision may conduct the sale or 19 exchange unless the governor gives the political subdivision 20 21 written notice disapproving the sale or exchange. The governor must provide written notice of disapproval under this section not 22 23 later than the 30th day after the date the governor receives the 24 written request for approval.

6	POSTED ON WEBSITE. (a) The General Land Office shall post
7	information relating to the conveyance of any public land by a
8	political subdivision to the United States, including land sold or
9	exchanged for use as a federal post office, on the agency's Internet
10	website. The information must be publicly accessible and include
11	the following for each sale or exchange:
12	(1) the entity acquiring the land;
13	(2) the entity offering the land for sale or exchange;
14	(3) the purchase price of the land or the value of the
15	property for which the land was exchanged; and
16	(4) the date of the sale or exchange.
17	(b) A political subdivision shall provide the General Land
18	Office the information described by Subsection (a) not later than
19	the 30th day after the date the land is sold or exchanged.
20	(c) The commissioner of the General Land Office shall adopt
21	any rules necessary to implement this section.
22	SECTION 3. The changes in law made by this Act do not apply
23	to the sale or exchange of land for which:
24	(1) notice of the offer of the sale or exchange is
