2	relating to the establishment of veterans resource centers at
3	certain institutions of higher education.
4	BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF TEXAS:
5	SECTION 1. Chapter 434, Government Code, is amended by
6	adding Subchapter J to read as follows:
7	SUBCHAPTER J. VETERANS RESOURCE CENTERS
8	Sec. 434.451. DEFINITIONS. In this subchapter:
9	(1) "Commission" means the Texas Veterans Commission.
10	(2) "Higher education regions" means the higher
11	education regions in this state established by the Texas Higher
12	Education Coordinating Board.
13	(3) "Institution of higher education" has the meaning
14	assigned by Section 61.003, Education Code.
15	Sec. 434.452. VETERANS RESOURCE CENTERS. The commission
16	shall administer a veterans resource center in at least one
17	institution of higher education in each region specified in Section
18	<u>434.453 to:</u>
19	(1) provide a centralized place for veterans to find
20	assistance and information while enrolled at an institution of
21	higher education;
22	(2) deliver innovative, cost-effective programs to
23	attract veterans and family members of veterans to attend public

institutions of higher education;

1	(3) enable institutions of higher education to create
2	veteran-friendly environments;
3	(4) encourage veterans to take advantage of government
4	educational programs; and
5	(5) assist veterans in applying to public institutions
6	of higher education.
7	Sec. 434.453. LOCATIONS OF CENTERS. The commission shall
8	operate 15 veterans resource centers throughout this state with at
9	least one veterans resource center located in each of the following
10	higher education regions:
11	(1) High Plains Region;
12	(2) Northwest Texas Region;
13	(3) Metroplex Region;
14	(4) Upper East Texas Region;
15	(5) Southeast Texas Region;
16	(6) Gulf Coast Region;
17	(7) Central Texas Region;
18	(8) South Texas Region;
19	(9) West Texas Region; and
20	(10) Upper Rio Grande Region.
21	Sec. 434.454. DUTIES OF INSTITUTION OF HIGHER EDUCATION.
22	Each institution of higher education that has a veterans resource
23	center shall enter into a memorandum of understanding with the
24	commission. The memorandum of understanding must require the
25	institution of higher education to provide and bear the cost of the
26	<pre>following:</pre>
27	(1) office space on the campus of the institution of

- 1 higher education that is accessible to persons with disabilities
- 2 and complies with any applicable federal and state law; and
- 3 (2) office equipment, telephone equipment and
- 4 service, computer equipment, and Internet access.
- 5 Sec. 434.455. PROGRAM MANAGER. The commission shall employ
- 6 <u>a program manager to administer the veterans resource center</u>
- 7 program. The program manager shall:
- 8 <u>(1) provide leadership, training, support, and</u>
- 9 overall management of the veterans resource center program;
- 10 (2) evaluate the effectiveness of veterans resource
- 11 centers in identifying the services required by veterans to
- 12 optimize the success of veterans and their families in obtaining a
- 13 college education and in providing those services;
- 14 (3) supervise the regional veterans resource
- 15 <u>counselors;</u>
- 16 <u>(4) prepare an annual budget;</u>
- 17 (5) monitor the outcomes of the veterans resource
- 18 center program;
- 19 (6) using data provided by the Texas Higher Education
- 20 Coordinating Board, produce an annual report on veterans'
- 21 attendance at public institutions of higher education;
- 22 (7) apply to private organizations and foundations for
- 23 grant funding or other support that complements the objectives of
- 24 the program; and
- 25 (8) perform any other task required by the commission.
- Sec. 434.456. REGIONAL VETERANS RESOURCE COUNSELORS. (a)
- 27 The commission shall employ a regional veterans resource counselor

- 1 for each higher education region to oversee the veterans resource
- 2 center or centers located in the region.
- 3 (b) A regional veterans resource counselor shall maintain
- 4 an office at a veterans resource center at an institution of higher
- 5 education located in the higher education region served by the
- 6 counselor.
- 7 (c) Each regional veterans resource counselor shall:
- 8 (1) visit each institution of higher education located
- 9 in the higher education region served by the counselor;
- 10 (2) work with those institutions of higher education
- 11 described by Subdivision (1) to:
- 12 (A) create a hospitable and supportive
- 13 environment for veterans;
- 14 (B) enhance awareness of and encourage
- 15 participation in veterans educational programs and in commission
- 16 programs providing other services to veterans, including
- 17 employment and claims assistance services;
- (C) develop programs providing ancillary
- 19 assistance to veterans based on the unique needs of veterans and
- 20 their families;
- (D) ensure that veterans successfully complete
- 22 their education; and
- (E) promote the establishment of a student
- 24 veterans group on each campus in the region;
- 25 (3) work with local, state, and national veterans
- 26 groups, including the Veterans of Foreign Wars and the American
- 27 Legion, to promote educational opportunities and benefits to the

1	veteran population in the higher education region;
2	(4) work with local workforce development boards to:
3	(A) ensure that veterans counselors are aware of
4	available nontraditional educational opportunities, including
5	on-the-job training programs and apprenticeships; and
6	(B) advise employers in the region of potential
7	opportunities to create on-the-job training programs for veterans;
8	(5) work with education services officers at military
9	installations to encourage active duty members of the armed forces
10	of the United States and veterans to use federal and state
11	educational benefits;
12	(6) create and manage publicity campaigns in concert
13	with the commission and institutions of higher education in the
14	higher education region to promote the use of education benefits
15	under the federal Post-9/11 Veterans Educational Assistance Act of
16	2008 (38 U.S.C. Section 3301 et seq.), the tuition exemption
17	program for veterans and their dependents under Section 54.341,
18	Education Code, and any other education benefit for veterans or
19	their dependents under federal or state law;
20	(7) support programs to assist combat veteran students
21	in readjusting and reintegrating into a noncombat environment;
22	(8) maintain statistical information regarding
23	demographics of veterans assisted, application success, program
24	completion rates, dropout rates, and reasons for success or
25	failure, as appropriate; and
26	(9) perform other activities, as assigned by the
27	commission, to enhance the educational opportunities of veterans
