## A BILL TO BE ENTITLED

1 AN ACT

2 relating to voter approval of a proposed ad valorem tax rate that

- 3 exceeds the rollback tax rate.
- 4 BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF TEXAS:
- 5 SECTION 1. The heading to Section 26.08, Tax Code, is
- 6 amended to read as follows:
- 7 Sec. 26.08. ELECTION TO RATIFY TAX RATE [SCHOOL TAXES].
- 8 SECTION 2. Sections 26.08(a), (b), (d), (d-1), (d-2), (e),
- 9 and (h), Tax Code, are amended to read as follows:
- 10 (a) If the governing body of a taxing unit [school district]
- 11 adopts a tax rate that exceeds the taxing unit's [district's]
- 12 rollback tax rate, the registered voters of the taxing unit
- 13 [district] at an election held for that purpose must determine
- 14 whether to approve the adopted tax rate. When increased
- 15 expenditure of money by a taxing unit [school district] is
- 16 necessary to respond to a disaster, including a tornado, hurricane,
- 17 flood, or other calamity, but not including a drought, that has
- 18 impacted the taxing unit [a school district] and the governor has
- 19 requested federal disaster assistance for the area in which the
- 20 <u>taxing unit</u> [school district] is located, an election is not
- 21 required under this section to approve the tax rate adopted by the
- 22 governing body for the year following the year in which the disaster
- 23 occurs.
- (b) The governing body shall order that the election be held

- in the <u>taxing unit</u> [school district] on a date not less than 30 or 1 more than 90 days after the day on which it adopted the tax rate. 2 Section 41.001, Election Code, does not apply to the election 3 unless a date specified by that section falls within the time 4 permitted by this section. At the election, the ballots shall be 5 permit voting for or 6 prepared to against proposition: "Approving the ad valorem tax rate of \$\_\_\_\_\_ per \$100 7 8 valuation in (name of taxing unit [school district]) for the current year, a rate that is \$\_\_\_\_\_ higher per \$100 valuation than 9 the [school district] rollback tax rate of (name of taxing unit), 10 for the purpose of (description of purpose of increase)." 11 12 ballot proposition must include the adopted tax rate and the difference between that rate and the rollback tax rate in the 13
- (d) If the proposition is not approved as provided by Subsection (c), the governing body may not adopt a tax rate for the taxing unit [school district] for the current year that exceeds the taxing unit's [school district's] rollback tax rate.

appropriate places.

19 (d-1) If, after tax bills for the taxing unit [school district] have been mailed, a proposition to approve the taxing 20 unit's [school district's] adopted tax rate is not approved by the 21 voters of the taxing unit [district] at an election held under this 22 23 section, on subsequent adoption of a new tax rate by the governing 24 body of the <u>taxing unit</u> [<u>district</u>], the assessor for the <u>taxing unit</u> [school] shall prepare and mail corrected tax bills. The assessor 25 shall include with each bill a brief explanation of the reason for 26 27 and effect of the corrected bill. The date on which the taxes

- 1 become delinquent for the year is extended by a number of days equal
- 2 to the number of days between the date the first tax bills were sent
- 3 and the date the corrected tax bills were sent.
- 4 (d-2) If a property owner pays taxes calculated using the
  5 originally adopted tax rate of the <u>taxing unit</u> [school district]
  6 and the proposition to approve the adopted tax rate is not approved
  7 by the voters, the taxing unit [school district] shall refund the
- 8 difference between the amount of taxes paid and the amount due under
- 9 the subsequently adopted rate if the difference between the amount
- 10 of taxes paid and the amount due under the subsequent rate is \$1 or
- 11 more. If the difference between the amount of taxes paid and the
- 12 amount due under the subsequent rate is less than \$1, the taxing
- 13 unit [school district] shall refund the difference on request of
- 14 the taxpayer. An application for a refund of less than \$1 must be
- 15 made within 90 days after the date the refund becomes due or the
- 16 taxpayer forfeits the right to the refund.
- 17 (e) For purposes of this section, local tax funds dedicated
- 18 to a junior college district under Section 45.105(e), Education
- 19 Code, shall be eliminated from the calculation of the tax rate
- 20 adopted by the governing body of  $\underline{a}$  [the] school district. However,
- 21 the funds dedicated to the junior college district are subject to
- 22 Section 26.085.
- 23 (h) For purposes of this section, increases in taxable
- 24 values and tax levies occurring within a reinvestment zone under
- 25 Chapter 311 (Tax Increment Financing Act), in which a school [the]
- 26 district is a participant, shall be eliminated from the calculation
- 27 of the tax rate adopted by the governing body of the school

- 1 district.
- 2 SECTION 3. Section 26.16(d), Tax Code, is amended to read as
- 3 follows:
- 4 (d) The county assessor-collector shall post immediately
- 5 below the table prescribed by Subsection (c) the following
- 6 statement:
- 7 "The county is providing this table of property tax rate
- 8 information as a service to the residents of the county. Each
- 9 individual taxing unit is responsible for calculating the property
- 10 tax rates listed in this table pertaining to that taxing unit and
- 11 providing that information to the county.
- "The adopted tax rate is the tax rate adopted by the governing
- 13 body of a taxing unit.
- "The maintenance and operations rate is the component of the
- 15 adopted tax rate of a taxing unit that will impose the amount of
- 16 taxes needed to fund maintenance and operation expenditures of the
- 17 unit for the following year.
- 18 "The debt rate is the component of the adopted tax rate of a
- 19 taxing unit that will impose the amount of taxes needed to fund the
- 20 unit's debt service for the following year.
- "The effective tax rate is the tax rate that would generate
- 22 the same amount of revenue in the current tax year as was generated
- 23 by a taxing unit's adopted tax rate in the preceding tax year from
- 24 property that is taxable in both the current tax year and the
- 25 preceding tax year.
- 26 "The effective maintenance and operations rate is the tax
- 27 rate that would generate the same amount of revenue for maintenance

- 1 and operations in the current tax year as was generated by a taxing
- 2 unit's maintenance and operations rate in the preceding tax year
- 3 from property that is taxable in both the current tax year and the
- 4 preceding tax year.
- 5 "The rollback tax rate is the highest tax rate a taxing unit
- 6 may adopt before requiring voter approval at an election.  $\underline{An}$  [ $\underline{In}$
- 7 the case of a taxing unit other than a school district, the voters
- 8 by petition may require that a rollback election be held if the unit
- 9 adopts a tax rate in excess of the unit's rollback tax rate. In the
- 10 case of a school district, an] election will automatically be held
- 11 if <u>a taxing unit</u> [the district] wishes to adopt a tax rate in excess
- 12 of the unit's [district's] rollback tax rate."
- SECTION 4. Sections 31.12(a) and (b), Tax Code, are amended
- 14 to read as follows:
- 15 (a) If a refund of a tax provided by Section 11.431(b),
- 16  $\frac{26.08(d-2)}{(d-2)}$  [ $\frac{26.07(g)}{(g)}$ ], 26.15(f), 31.11, or 31.111 is paid on or
- 17 before the 60th day after the date the liability for the refund
- 18 arises, no interest is due on the amount refunded. If not paid on or
- 19 before that 60th day, the amount of the tax to be refunded accrues
- 20 interest at a rate of one percent for each month or part of a month
- 21 that the refund is unpaid, beginning with the date on which the
- 22 liability for the refund arises.
- 23 (b) For purposes of this section, liability for a refund
- 24 arises:
- 25 (1) if the refund is required by Section 11.431(b), on
- 26 the date the chief appraiser notifies the collector for the unit of
- 27 the approval of the late homestead exemption;

- 4 (3) if the refund is required by Section 26.15(f):
- 5 (A) for a correction to the tax roll made under
- 6 Section 26.15(b), on the date the change in the tax roll is
- 7 certified to the assessor for the taxing unit under Section 25.25;
- 8 or
- 9 (B) for a correction to the tax roll made under
- 10 Section 26.15(c), on the date the change in the tax roll is ordered
- 11 by the governing body of the taxing unit;
- 12 (4) if the refund is required by Section 31.11, on the
- 13 date the auditor for the taxing unit determines that the payment was
- 14 erroneous or excessive or, if the amount of the refund exceeds the
- 15 applicable amount specified by Section 31.11(a), on the date the
- 16 governing body of the unit approves the refund; or
- 17 (5) if the refund is required by Section 31.111, on the
- 18 date the collector for the taxing unit determines that the payment
- 19 was erroneous.
- SECTION 5. Section 33.08(b), Tax Code, is amended to read as
- 21 follows:
- (b) The governing body of the taxing unit or appraisal
- 23 district, in the manner required by law for official action, may
- 24 provide that taxes that become delinquent on or after June 1 under
- 25 Section 26.08(d-1) [<del>26.07(f)</del>], 26.15(e), 31.03, 31.031, 31.032,
- 26 31.04, or 42.42 incur an additional penalty to defray costs of
- 27 collection. The amount of the penalty may not exceed the amount of

- 4 SECTION 6. Section 130.016(b), Education Code, is amended

- 16 "A tax rate of \$\_\_\_\_\_ per \$100 valuation has been proposed for
- 17 adoption by the governing body of (insert name of county or
- 18 municipality). This rate exceeds the lower of the effective or
- 19 rollback tax rate, and state law requires that two public hearings
- 20 be held by the governing body before adopting the proposed tax

- 13 (B) the difference, expressed as an amount per
- 14 \$100 and as a percent increase or decrease, as applicable, in the
- 15 proposed tax rate compared to the adopted tax rate for the preceding
- 16 year;
- 17 (C) the average appraised value of a residence
- 18 homestead in the district in the preceding year and in the current
- 19 year; the district's total homestead exemption, other than an
- 20 exemption available only to disabled persons or persons 65 years of
- 21 age or older, applicable to that appraised value in each of those
- 22 years; and the average taxable value of a residence homestead in the
- 23 district in each of those years, disregarding any homestead
- 24 exemption available only to disabled persons or persons 65 years of
- 25 age or older;
- 26 (D) the amount of tax that would have been
- 27 imposed by the district in the preceding year on a residence

- 1 homestead appraised at the average appraised value of a residence
- 2 homestead in that year, disregarding any homestead exemption
- 3 available only to disabled persons or persons 65 years of age or
- 4 older;
- 5 (E) the amount of tax that would be imposed by the
- 6 district in the current year on a residence homestead appraised at
- 7 the average appraised value of a residence homestead in that year,
- 8 disregarding any homestead exemption available only to disabled
- 9 persons or persons 65 years of age or older, if the proposed tax
- 10 rate is adopted; [and]
- 11 (F) the difference between the amounts of tax
- 12 calculated under Paragraphs (D) and (E), expressed in dollars and
- 13 cents and described as the annual percentage increase or decrease,
- 14 as applicable, in the tax to be imposed by the district on the
- 15 average residence homestead in the district in the current year if
- 16 the proposed tax rate is adopted; and
- 17 (G) if the proposed combined debt service,
- 18 operation and maintenance, and contract tax rate exceeds the
- 19 rollback tax rate, a description of the purpose of the proposed tax
- 20 <u>increase; and</u>
- 21 (3) contain a statement in substantially the following
- 22 form:
- 23 "NOTICE OF <u>VOTE ON TAX RATE</u> [<del>TAXPAYERS' RIGHT TO ROLLBACK ELECTION</del>]
- "If operation and maintenance taxes on the average residence
- 25 homestead increase by more than eight percent, [the qualified
- 26 voters of the district by petition may require that] an election
- 27 must be held to determine whether to ratify [reduce] the operation

1 and maintenance tax rate [to the rollback tax rate] under Section
2 49.236(d), Water Code."

- (d) If the governing body of a district adopts a combined debt service, operation and maintenance, and contract tax rate that exceeds the rollback tax rate, [would impose more than 1.08 times the amount of tax imposed by the district in the preceding year on a residence homestead appraised at the average appraised value of a residence homestead in the district in that year, disregarding any homestead exemption available only to disabled persons or persons 65 years of age or older, the qualified voters of the district by petition may require that] an election must be held to determine whether [or not] to ratify [reduce] the tax rate adopted for the current year [to the rollback tax rate] in accordance with the procedures provided by Sections 26.08(b)-(d) [26.07(b)-(g) and 26.081], Tax Code. For purposes of Sections 26.08(b)-(d) [26.07(b)-(g)] and this section [subsection], the rollback tax rate is the sum of the following tax rates:
- 18 (1) the current year's debt service tax rate;
- 19 (2) the current year's [and] contract tax rate; and
- 20 (3) [rates plus] the operation and maintenance tax 21 rate that would impose 1.08 times the amount of the operation and 22 maintenance tax imposed by the district in the preceding year on a 23 residence homestead appraised at the average appraised value of a 24 residence homestead in the district in that year, disregarding any 25 homestead exemption available only to disabled persons or persons 26 65 years of age or older.
- 27 SECTION 14. The following provisions are repealed:

- 1 (1) Section 1063.255, Special District Local Laws
- 2 Code;
- 3 (2) Section 26.07, Tax Code;
- 4 (3) Section 49.236, Water Code, as added by Chapter
- 5 248 (H.B. 1541), Acts of the 78th Legislature, Regular Session,
- 6 2003; and
- 7 (4) Section 49.2361, Water Code.
- 8 SECTION 15. (a) The change in law made by this Act applies
- 9 to the ad valorem tax rate of a taxing unit beginning with the 2017
- 10 tax year, except as provided by Subsection (b) of this section.
- 11 (b) If the governing body of a taxing unit adopted an ad
- 12 valorem tax rate for the taxing unit for the 2017 tax year before
- 13 the effective date of this Act, the change in law made by this Act
- 14 applies to the ad valorem tax rate of that taxing unit beginning
- 15 with the 2018 tax year, and the law in effect when the tax rate was
- 16 adopted applies to the 2017 tax year with respect to that taxing
- 17 unit.
- 18 SECTION 16. This Act takes effect immediately if it
- 19 receives a vote of two-thirds of all the members elected to each
- 20 house, as provided by Section 39, Article III, Texas Constitution.
- 21 If this Act does not receive the vote necessary for immediate
- 22 effect, this Act takes effect on the 91st day after the last day of
- 23 the legislative session.
