4	BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF TEXAS:
5	SECTION 1. Chapter 322, Government Code, is amended by
6	adding Section 322.025 to read as follows:
7	Sec. 322.025. REPORT ON BORDER SECURITY OPERATIONS. (a) In
8	this section:
9	(1) "Border security" means the activities in a
10	reportable county associated with deterring crimes and enforcing
11	state laws related to:
12	(A) an offense under Chapters 19, 20, 20A, 22,
13	34, 36, 46, and 71, Penal Code, that is punishable as a felony of the
14	third degree or higher;
15	(B) an offense under Chapter 481, Health and
16	Safety Code, that is punishable as a felony of the third degree or
17	higher;
18	(C) an offense under Section 31.03, Penal Code,
19	in which the actor obtained another person's property by using
20	actual or threatened force, violence, or fear or under the color of
21	official right;

(D) any offense that is coordinated with or

1	(E) any offense for which the state receives
2	federal money to enhance law enforcement efforts relating to the
3	offense.
4	(2) "Reportable county" means a county:
5	(A) adjacent to or a portion of which is located
6	within 20 miles of an international border;
7	(B) adjacent to two counties located on an
8	international border with a population of more than 5,000 and less
9	than 7,500 according to the most recent decennial census;
10	(C) adjacent to the Gulf Intracoastal Waterway,
11	as defined by Section 51.002, Transportation Code; or
12	(D) with a population of more than 1 million.
13	(b) The Department of Public Safety, Texas Military
14	Department, Parks and Wildlife Department, trusteed programs
15	within the office of the governor, Texas Department of Criminal
16	Justice, and any other state agency designated by the board shall
17	report to the board twice each state fiscal year of the fiscal
18	biennium ending August 31, 2019, the following:
19	(1) the amount of money the agency budgeted for border
20	security and the amount of money the agency spent on border security
21	during the reporting period in each reportable county and
22	statewide;
23	(2) the method of finance for budgeted and expended
24	amounts;
25	(3) the object of expense for budgeted and expended
26	amounts;
27	(4) the amount of money the agency spent on employee

- 2 security, including regular and overtime pay, in each reportable
- 3 county and statewide;
- 4 (5) the agency's performance related to border
- 5 security during the reporting period in each reportable county and
- 6 statewide including:
- 7 (A) the arrest rates measuring the number of
- 8 arrests by the agency in the state fiscal year compared to an
- 9 average of the number of arrests in the immediately preceding five
- 10 state fiscal years for human trafficking, illicit drug
- 11 transportation or smuggling, stolen vehicles used in illicit drug
- 12 transportation or smuggling, smuggling of persons, and organized
- 13 crime;
- 14 (B) an illicit drugs seizure rate measuring the
- 15 amount and type of illicit drugs seized by the agency in the state
- 16 fiscal year compared to an average of the amount and type of illicit
- 17 drugs seized by the agency for the immediately preceding five
- 18 state fiscal years;
- 19 (C) the total number and an itemized list of
- 20 illicit drug interdictions in trafficking quantities by the agency;
- (D) the total number and an itemized list of
- 22 currency seizures connected to organized crime arrests with amounts
- 23 of currency by the agency; and
- (E) a currency seizure rate measuring the amount
- 25 of currency seized by the agency in the state fiscal year compared
- 26 to an average of the amount of currency seized by the agency for the
- 27 immediately preceding five state fiscal years; and

- 1 (6) any other information relating to the agency's
- 2 border security operations that the board may require.
- 3 (c) A state agency required by Subsection (b) to report
- 4 information to the board shall submit information for the first
- 5 half of a state fiscal year not later than March 31 of that year and
- 6 information for the second half of a state fiscal year not later
- 7 than September 30 of that year. The state agency shall submit the
- 8 information in the manner prescribed by the board.
- 9 (d) This section expires January 1, 2020.
- 10 SECTION 2. This Act takes effect September 1, 2017.
