(b) The changes in law made by this Act to 2-23 Section 31.023(a), Education Code, apply to instructional materials adopted by the State Board of Education on or after September 1, 2-24 2**-**25 2**-**26 2018.

2-27 Sections 31.023(b) and 31.035(a), Education Code, as (C) amended by this Act, apply only to an instructional material list or 2-28 supplemental instructional material adopted on or after the effective date of this Act.
