A BILL TO BE ENTITLED

1 AN ACT

2 relating to the sale of fireworks during and before the Diwali

- 4 BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF TEXAS:
- 5 SECTION 1. Section 2154.202(h), Occupations Code, is
- 6 amended to read as follows:
- 7 (h) In addition to the periods during which the sale of
- 8 fireworks is authorized under Subsection (g), the commissioners
- 9 court of a county by order may allow a retail fireworks permit
- 10 holder to sell fireworks in that county only to the public and only
- 11 during one or more of the following periods:
- 12 (1) beginning February 25 and ending at midnight on
- 13 March 2;
- 14 (2) beginning April 16 and ending at midnight on April
- 15 21; [and]
- 16 (3) beginning the Wednesday before the last Monday in
- 17 May and ending at midnight on the last Monday in May; and
- 18 (4) beginning five days before the first day of Diwali
- 19 and ending at midnight on the last day of Diwali.
- 20 SECTION 2. Sections 352.051(b) and (d), Local Government
- 21 Code, are amended to read as follows:
- (b)(1) The Texas A&M Forest Service in the ordinary course

- 24 defined under Subsection (a)(2), exist on average in any county

- 1 requesting such a determination. The Texas $\underline{A\&M}$ Forest Service
- 2 shall make available the measurement index guidelines used to

- 4 Following any determination that such drought conditions exist, the
- 5 Texas A&M Forest Service shall notify said county or counties when
- 6 such drought conditions no longer exist. The Texas A&M Forest
- 7 Service shall make its services available each day during the Texas
- 8 Independence Day, San Jacinto Day, Memorial Day, Fourth of July,
- 9 Diwali, and December fireworks seasons to respond to the request of
- 10 any county for a determination whether drought conditions exist on

- 12 (2) The Texas A&M Forest Service shall be allowed to
- 13 take such donations of equipment or funds as necessary to aid in the

- 15 (d) To facilitate compliance with an order adopted under
- 16 Subsection (c), the order must be adopted before:
- 17 (1) February 15 of each year for the Texas
- 18 Independence Day fireworks season;
- 19 (2) April 1 of each year for the San Jacinto Day

- 21 (3) April 25 of each year for the Cinco de Mayo
- 22 fireworks season;
- 23 (4) May 15 of each year for the Memorial Day fireworks

- 25 (5) June 15 of each year for the Fourth of July

- $\underline{(7)}$ December 15 of each year for each December
- 3 fireworks season.
- 4 SECTION 3. This Act takes effect September 1, 2017.
