## A BILL TO BE ENTITLED

1	AN ACT

- 2 relating to the transfer of certain functions related to emergency
- 3 services districts from the Department of Agriculture to the Texas
- 4 Division of Emergency Management.
- 5 BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF TEXAS:
- 6 SECTION 1. Section 487.061, Government Code, is transferred
- 7 to Subchapter C, Chapter 418, Government Code, redesignated as
- 8 Section 418.053, Government Code, and amended to read as follows:
- 9 Sec. 418.053 [487.061]. EMERGENCY SERVICES DISTRICT
- 10 PROGRAM. (a) The division [department] shall serve as a resource
- 11 to provide interested rural communities with:
- 12 (1) general information about emergency services
- 13 districts; and
- 14 (2) information and training related to the
- 15 establishment of an emergency services district.
- 16 (b) The division [department] may:
- 17 (1) provide to fire departments in rural areas
- 18 information relating to assistance programs offered to rural
- 19 volunteer firefighters, including the federal Staffing for
- 20 Adequate Fire and Emergency Response grant program to help fire
- 21 departments increase staffing and deployment capabilities; and
- 22 (2) provide to rural homeowners information relating
- 23 to the benefits of volunteer fire departments, including a
- 24 reduction in homeowners insurance risk ratings, lower homeowners

- 1 insurance rates, and better fire protection.
- 2 SECTION 2. Sections 775.083(a), (b), and (c), Health and
- 3 Safety Code, are amended to read as follows:
- 4 (a) On or before January 1 of each year, a district shall
- 5 file with the Texas Division of Emergency Management [Department of
- 6 Rural Affairs] an annual report that includes the following:
- 7 (1) the district's name;
- 8 (2) the name of each county in which the district is
- 9 located;
- 10 (3) the district's business address;
- 11 (4) the name, mailing address, and term of office of
- 12 each commissioner;
- 13 (5) the name, mailing address, and term of office of
- 14 the district's general manager, executive director, and fire chief;
- 15 (6) the name of each legal counsel or other consultant
- 16 for the district; and
- 17 (7) the district's annual budget and tax rate for the
- 18 preceding fiscal year.
- 19 (b) The Texas <u>Division of Emergency Management</u> [<del>Department</del>
- 20 of Rural Affairs | may not charge a fee for filing the report.
- 21 (c) The Texas <u>Division of Emergency Management</u> [<del>Department</del>
- 22 of Rural Affairs] shall develop and maintain an Internet-based
- 23 system that enables:
- 24 (1) a district to securely file the report and update
- 25 the district's information; and
- 26 (2) the public to view, in a searchable format, the
- 27 reports filed by districts under this section.

- 1 SECTION 3. Not later than January 1, 2018, the following are
- 2 transferred from the Department of Agriculture to the Texas
- 3 Division of Emergency Management:
- 4 (1) the powers, duties, functions, programs, and
- 5 activities of the Department of Agriculture relating to the duties
- 6 described by Section 418.053, Government Code, as transferred,
- 7 redesignated, and amended by this Act;
- 8 (2) any obligations and contracts of the Department of
- 9 Agriculture that are directly related to implementing a power,
- 10 duty, function, program, or activity described by Subdivision (1)
- 11 of this section; and
- 12 (3) all property and records in the custody of the
- 13 Department of Agriculture that are related to a power, duty,
- 14 function, program, or activity described by Subdivision (1) of this
- 15 section and all funds appropriated by the legislature for that
- 16 power, duty, function, program, or activity.
- 17 SECTION 4. The change in law made by this Act to Section
- 18 775.083, Health and Safety Code, applies only to an annual report
- 19 due on or after January 1, 2019. An annual report due before
- 20 January 1, 2019, is governed by the law as it existed immediately
- 21 before the effective date of this Act, and that law is continued in
- 22 effect for that purpose.
- 23 SECTION 5. This Act takes effect September 1, 2017.
