- 5 BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF TEXAS:
- 6 SECTION 1. Section 223.201(j), Transportation Code, is
- 7 amended to read as follows:
- 8 (j) Before the department may enter into a comprehensive
- 9 development agreement under Subsection (f), the department must:
- 10 (1) for a project other than the State Highway 99
- 11 (Grand Parkway) project, obtain, not later than August 31, 2023
- 12 [2017], the appropriate environmental clearance:
- 13 (A) for the project; or
- 14 (B) for the initial or base scope of the project
- 15 if the project agreement provides for the phased construction of
- 16 the project; and
- 17 (2) present to the commission a full financial plan
- 18 for the project, including costing methodology and cost proposals.
- 19 SECTION 2. Sections 223.2011(a), (c), and (f),
- 20 Transportation Code, are amended to read as follows:
- 21 (a) Notwithstanding Sections 223.201(f) and 370.305(c), the
- 22 department or an authority under Section 370.003 may enter into a
- 23 comprehensive development agreement relating to improvements to,
- 24 or construction of, all or part of:

- 1 (1) the Loop 1 (MoPac Improvement) project from
- 2 Farm-to-Market Road 734 to Cesar Chavez Street;
- 3 (2) the U.S. 183 (Bergstrom Expressway) project from
- 4 Springdale Road to Patton Avenue;
- 5 (3) a project consisting of the construction of:
- 6 (A) the Outer Parkway Project in Cameron County
- 7 from U.S. Highway 77 to Farm-to-Market Road 1847; and
- 8 (B) the South Padre Island Second Access Causeway
- 9 Project from State Highway 100 to Park Road 100;
- 10 (4) the Loop 49 project from Interstate 20 to U.S.
- 11 Highway 69 (Lindale Relief Route) and from State Highway 110 to U.S.
- 12 Highway 259 (Segments 6 and 7);
- 13 (5) the Loop 375 Border Highway West project in El Paso
- 14 County from Race Track Drive to U.S. Highway 54;
- 15 (6) the Northeast Parkway project in El Paso County
- 16 from Loop 375 east of the Railroad Drive overpass to the Texas-New
- 17 Mexico border;
- 18 (7) the Loop 1604 project in Bexar County;
- 19 (8) the Hidalgo County Loop project; [and]
- 20 (9) the International Bridge Trade Corridor project;
- 21 <u>and</u>
- 22 (10) the Farm-to-Market 1925 project from U.S. Highway
- 23 281 in Hidalgo County to U.S. Highway 77 in Cameron County.
- (c) Not later than December 1, 2018 [2014], the department
- 25 or the authority, as applicable, shall provide a report to the
- 26 commission on the status of a project described by Subsection
- 27 (a). The report must include:

- 1 (1) the status of the project's environmental
- 2 clearance;
- 3 (2) an explanation of any project delays; and
- 4 (3) if the procurement is not completed, the
- 5 anticipated date for the completion of the procurement.
- 6 (f) The authority to enter into a comprehensive development
- 7 agreement under this section expires August 31, 2023 [2017].
- 8 SECTION 3. This Act takes effect immediately if it receives
- 9 a vote of two-thirds of all the members elected to each house, as
- 10 provided by Section 39, Article III, Texas Constitution. If this
- 11 Act does not receive the vote necessary for immediate effect, this
- 12 Act takes effect August 28, 2017.
